I, Savita Jyoti, (Membership No. F3738 and C.P. No.1796), M/s. Savita Jyoti Associates, Company Secretaries, was appointed as Scrutinizer by POWERGRID Unchahar Transmission Limited (the "Investment Manager"), the Investment Manager of POWERGRID Infrastructure Investment Trust ("PGInvIT") to scrutinize the remote e-voting process and voting by electronic means conducted at Third Annual Meeting ("Annual Meeting") of PGInvIT in a fair and transparent manner.

Pursuant to the relevant provisions of Master circular no. SEBI/HO/DDHS-PoD-2/P/CIR/2024/44 dated May 15, 2024 issued by the Securities and Exchange Board of India ("SEBI"), the Infrastructure Investment Trusts set up under the SEBI (Infrastructure Investment Trusts) Regulations, 2014, as amended or supplemented ("InvIT Regulations") have been permitted to hold the Annual Meeting through Video Conferencing ("VC")/ Other Audio Visual Means ("OAVM"). Pursuant to the applicable provisions of the InvIT Regulations read with above-mentioned circular, the Annual Meeting of PGInvIT was conducted on Wednesday, June 26, 2024, at 2:30 P.M. (IST) through VC.

The notice convening the Annual Meeting of PGInvIT dated May 31, 2024 ("Notice of the Annual Meeting") alongwith Annual Report for the Financial Year 2023-24 was sent through electronic means to those Unitholders whose e-mail addresses were registered with the depositories / depository participants.

The Investment Manager on behalf of PGInvIT had engaged the services of M/s. KFin Technologies Limited ("KFintech"), the Registrar and Transfer Agent ("RTA") of PGInvIT for the purpose of providing facility for voting through remote e-voting, for participation in the Annual Meeting through VC facility and e-voting during the Annual Meeting.
