Pursuant to Regulation 30 of Listing Regulations, we hereby inform that the Board of Directors of Somany Ceramics Limited ("Company"), in its meeting held on 15th January, 2025 has decided to sell the Company's equity stake in Amora Tiles Private Limited ("ATPL"), Subsidiary Company of the Company. The Company is holding 51.00% of the total paid-up capital of ATPL and it has decided to sell its entire stake/investment in the equity shares of ATPL ("Proposed Transaction").

Consequently, ATPL will cease to be the Company's Subsidiary Company after the disinvestment.

The meeting of Board of Directors was commenced at 12:15 p.m. and concluded at 01:45 p.m.
