

नवी दिल्ली - अवेध आर्थिक व्यवहारप्रकरणी रॉबर्ट वड्डा आज ईडीसमोर चौथ्यांदा हजर झाले. याप्रकरणी त्यांची आधी ईडीकडून ३ वेळा चौकशी झाली आहे. मात्र, माध्यमांमध्ये आलेल्या वृत्तानुसार वड्डा यांनी लंडनमध्ये कोणत्याही प्रकारची संपत्ती नसल्याचे सांगितले आहे. संजय भंडारी आणि आपला काहीही संबंध नाही. तसेच मनोज अरोरा यांनाही ओळखत असल्याचे त्यांनी म्हटले आहे. अरोरा यांच्या माध्यमातूनच वड्डा यांनी लंडनमध्ये संपत्ती खरेदी केल्याचा आरोप त्यांच्यावर आहे. भंडारी हे सिटिक इंटरनॅशनल या कंपनीचे मालक आहेत. लंडनच्या ब्रायनस्टन स्क्वेयर परिसरातील १७.६१ कोटी रुपयांची जमीन वाड्डा यांनी पेशांची अपफातफर करून खरेदी केल्याचा आरोप ईडीकडून करण्यात आला आहे. यावेळी रॉबर्ट वड्डा यांनी आपली लंडनमध्ये कोणतीही संपत्ती नसल्याचा दावा केला.
