(c) The Securities and Exchange Board of India vide its Adjudication Order No.: Order/SR/SM/2020-21/8433/47 dated 30th July, 2020 imposed penalty of Rs. 12,00,000/- on the listed entity. The listed entity challenged the said order before the Securities Appellate Tribunal ('SAT') Mumbai and SAT vide its order dated 1st December, 2020 quashed the Order of the AO of the SEBI. SEBI filed the Civil Appeal before the Hon'ble Supreme Court of India challenging the Order dated 1st December, 2020 passed by the Hon'ble SAT quashing and setting aside the order passed by the AO

of the SEBI for imposing cost of Rs. 12,00,000/- on the listed entity. The said matter was pending before the Hon'ble Supreme Court as on 31st March, 2024.
