Killed my husband for 40 lakhs

Surat, There has been a new twist in the suicide case of Pune-based Rakesh Chaudhary, a cloth trader, who jumped to his death from the window of room number 104 of the fourth floor of Dinduraj Hotel Light Inn in Surat after locking the bathroom door from inside.

four people, Sushil Joshi, Harish, Gautam and Jayesh, kidnapped Rakesh from Pune and kept him in a hotel here and demanded 40 lakh rupees.

After abducting a businessman, it was revealed that he committed suicide due to torture after torturing 40 lakhs of Pathani and keeping him tied up in a hotel. Two days later, the body was handed over to the family after the postmortem. The wife said that my husband was forced to die by six people. My husband has been murdered, catch the culprits quickly and give them capital punishment, not severe punishment. My father-in-law is paralysed, my mother-in-law is mentally ill and has a six-year-old daughter. These people have taken away our base. Rakesh Pancharam Chaudhary, 35, originally from Rajasthan, lived with his family in Pune, Maharashtra. The family consists of his father, wife and a six-year-old daughter. Rakesh got married to Pooja eight years ago. Rakesh owned a textile shop named Padmavati Collection and was a businessman. Since Rakesh's business was not doing well, he came to Surat, Tamil Nadu, he used to come and go. On August 6, Rakesh, who left home in Pune, Maharashtra, was abducted from the road and taken to Surat. Since August 7, Rakesh was kept in room number 104 of the fourth floor of Madhuram Arcade in Dindoli area. These
