(IST) through Video Conferencing/Other Audio Visual Means.

I Brij Kishor Gupta, Partner of BKG & Associates, Practicing Chartered Accountant (FRN: 114852W) had been appointed as Scrutinizer pursuant to Sections 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended to conduct the remote evoting process and e-voting process in respect of the below mentioned resolutions proposed at the 30thAnnual General Meeting ("AGM") of Upsurge Investment And Finance Limited ("The Company"), held on Monday, September 30, 2024 at 1:00 P.M. (IST) through Video Conferencing ('VC') / Other Audio Visual Means ('OAVM').

1. The AGM Notice was circulated by the Company to the shareholders whose email addresses are registered with the Company/Depositories for convening of AGM of the Company on Tuesday, August 27, 2024 at 1.00 P.M. (IST) through VC / OAVM to transact the business, as set out in the AGM Notice, as stated above, in compliance with the applicable provisions of the Companies Act, 2013 and Rules framed thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Circulars issued by MCA and SEBI permitting the Companies to hold General Meetings without the

physical presence of Members at a common venue. The dispatch of the Notice of AGM through e-mails was completed on Friday, September 6, 2024.

- 2. The Company had availed the remote e-voting and e-voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting remote e-voting/e-voting by the Shareholders of the Company.
- 3. The remote e-voting commenced from Wednesday, September 25, 2024 (9.00 A.M. IST) and ended on Sunday, September 29, 2024 (5.00 P.M. IST) and at the end of remote e-voting period, voting portal of service provider was blocked forthwith.
- 4. Members who had not casted their vote by remote e-voting were allowed to do e-voting at the AGM.
- 6. The Equity Shareholders holding shares as on Cut-off date i.e. Monday, September 23, 2024, were entitled to vote on the resolutions stated in the Notice of the AGM of the Company.
- 7. After the closure of e-voting at the AGM, the report on voting done at the AGM and the votes cast under remote e-voting facility prior to the AGM were unblocked and were counted.
