Subject - Proceedings of 30th Annual General Meeting of the Company held on 12th September 2024

SUMMARY PROCEEDINGS OF THE 30TH ANNUAL GENERAL MEETING OF THE MEMBERS OF THE SILVER TOUCH TECHNOLOGIES LIMITED

The 30th Annual General Meeting of the Members of the Company was held on September 12, 2024 at 4:30 PM through Video Conference (VC) / Other Audio Visual Means (OAVM).

- Mr. Vishnu Thaker, Company Secretary and Compliance Officer of the Company welcomed the shareholders at the Annual General Meeting. Company Secretary informed the Members that this AGM was conducted through VC / OAVM pursuant to the General Circular No. 14/2020 dated 8th April, 2020 and General Circular No. 17/2020 dated 13th April, 2020 followed by General Circular No. 02/2021 dated 13th January, 2021, General Circular No. 21/2021 dated 14th December, 2021, General Circular No. 02/2022 dated 5th May, 2022 and general Circular No. 10/2022 dated 28th December, 2023. This meeting has been convened and being conducted in accordance with mentioned circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India (SEBI). Further the Company had tied up with Central Depository Services (India) Limited to provide facility for voting through remote e-voting, e-voting during the AGM and for participation in the AGM through VC / OAVM. Company Secretary further informed that the requisite quorum being present the proceedings of the meeting can be commenced. The Company Secretary introduced the directors present in the meeting.

- Mr. Vipul Thakkar, Chairman and Managing Director of the Company chaired the meeting and welcomed the shareholders on behalf of the Company. He then addressed the shareholders and informed them about the performance of the Company during the financial year 2023-24.
- Company Secretary informed the Members about the instructions for participating in the AGM through video conference.
- Company Secretary, informed the Members, that the facility for appointment of proxies by the Members was not applicable as the AGM was held through video conference and hence the proxy register was not available for inspection, the documents/Statutory registers as per the regulatory requirement were available for inspection at the website of the Company till the conclusion of the AGM.
- Company Secretary, informed the Members, that pursuant to the provisions of the Companies Act, 2013, the Rules framed thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had extended the remote e-voting facility to the Members of the Company in respect of the resolutions to be passed at the Meeting. The remote e-voting commenced at **Monday, September 09, 2024 (09.00 a.m. IST) and closed on Wednesday, September 11, 2024 (5.00 p.m. IST)** also the facility for voting through e-voting system was made available during the Meeting for Members who had not cast their vote prior to the Meeting.
- With the consent of all the Members present, the Notice convening the 30th AGM, Independent Auditors' Report on Audited Financial statements, and Boards' Report along with Secretarial Auditor's Report various annexures and Reports thereto, for the financial year ended March 31, 2024 which had already been circulated to all the Members, were taken as read.
- Company Secretary informed the Members, that M/s. Sandip Sheth & Associates, Practicing Company Secretaries has been appointed as the Scrutinizer for conducting the remote e-voting in a fair and transparent manner. The Voting Results along with the Scrutinizers Report shall also be available on the website of the Company i.e. www.silvertouch.com as well as Website of National Stock Exchange of India Limited i.e. www.nseindia.com and Bombay Stock Exchange Limited (BSE) i.e. www.bseindia.com.
