I, Rabindra Kumar Samal, Company Secretary in Practice, has been appointed by the Board of Directors of M/s. - After the close of period for remote e-voting, the details of members, such as their names, folio numbers, numbers of shares held, who had cast votes through remote e-voting, were downloaded from the e-voting website of CDSL, for the purpose of ensuring that members who have cast their votes through




