During internal investigation irregularities pointed out by the Statutory Auditor were found true to full extent. The major observations are appended below-Sale proceeds were not credited in the account as per terms and conditions stipulated in the

Two currents accounts viz Axis Bank and Canara Bank were maintained by the company

which should have been closed within one month of the disbursement of the account but company failed to close there accounts. Interlocking of funds/investments in group concerns/cross movement of funds has been

observed as per below details Related Party/Sister/Allied/Associates/coNCern name amount involved as per ABS 2018- 19 Paras Das Industries Rs. 5.03 Crore Paras Das Jain and Sons Rs. 7.54 Crore PPM Co India Rs. 0.91 Crore Shree Prasa Das Jain Housing Pvt. Ltd. Rs. 2.23 Crore Shree Ram Ashiyana Pvt. Ltd. Rs. 0.62 Crore. Above said unsecured amounts lent to sister concerns dealing in housing and infra projects were not received back and thus funds were locked resulting in diversion of funds. Moreover, due to this company recorded loss pf Rs. 0.38 Crore in FY 2018-19 and subsequently in 2020 loss by Rs. 0.83 Crore.

 Related party transaction has been reported in ABS 2019-20 however detailes/ annexures of same is missing in the said balance sheet. An account being maintained at IDBI Bank India Ltd by the party as per 2018-19 but no information regarding the nature of the accounts is found.
