3 die after consuming 'jal jeera' in Kheda; cardiac arrest primary cause, says report

ADITI RAJA VADODARA, FEBRUARY 10

Three people have died after allegedly consuming a drink, suspected to be poisonous, in Kheda district's Nadiad town, said police on Monday, adding a probe has been launched into the matter.The incident took place Sunday night in Jawaharnagar area of the town.

On Monday evening, the primary cause of death - reported after the panel postmortem examination — of the three men was stated to be "cardiac arrest", Kheda even as the Superintendent of Police Raiesh Gadhiya handed over the investigation to the Local Crime

Police said that a case of unnatural death has been lodged at the Nadiad town police station as the investigators await the detailed forensic report to establish the nature of the toxic chemical that could have led to the deaths.

While the families of the three victims have claimed that the men consumed country liquor, the police have said that

"The same drink has been consumed by many other people on the same day but no other case has been reported. Therefore, the FSL team has collected the bottle that the three men drank from, along with a few others, from the dustbin near the shop where the bottle had been discarded," said the

Gadhiya added that the three men allegedly offered the drink to other people, including the eye-witness, but no one else consumed it from their bottle.

Gadhiya said, "It is bottled jeera soda that is sold in local stores. The primary FSL report has not indicated the presence of methanol, so it was not country liquor. But, we are investigating the possibility that the bottle that was brought by Kanu Chauhan could have been laced with poison... a similar case happened in Junagadh a few years ago. We are trying to ascertain if Chauhan purchased the bottle himself or it was given to him by someone, who intended to harm him."

Gadhiya added that the exact cause of death will be known after they receive the detailed histopathology report of the deceased. "Samples of their viscera have also been sent to the FSL Gandhinagar for a detailed report...the process is on to ascertain facts," said Gadhiya.

Meanwhile, the families of the deceased claimed that the men were "habitual drinkers" and indulged in consuming country liquor almost daily.

Victim Kanu Chauhan's un-

cle, PK Chauhan, said, "My nephew was hearing and speech impaired and used to earn a few rupees by setting up a weighing scale near the Jawaharnagar railway crossing. Whatever little money he made every evening, he would spend on country liquor. He had been drinking it for almost five years". "Last night, we received a call that he had collapsed. Within half an hour the three men died and I called the police." Chauhan added.

Another victim, Kushwah's son, Sunny, said, "My father used to sell fritters on his cart. He occasionally consumed country liquor. Last evening, too, he may have gone to consume the same brew. We do not know what he had... I received a call that he had met with an accident but when I reached the civil hospital, he was declared dead.'

SP Gadhiya said: "We are ascertaining what was in the drink. If it would have been country liquor, the presence of methanol in the blood sample would have confirmed it."

In November 2023, five people had died in three villages of Bilodra, Vadadla and Bagdu village in the district after allegedly consuming "spurious Ayurvedic syrup" Kal Meghasava, between November 26 and 28, 2023.

A Special Investigation Team (SIT) formed to investigate the case had arrested six people in the case after it had been established that the spurious ayurvedic syrup was manufactured in a unit in Nadiad by mixing sanitiser and misusing the Food and Drug Control Administration (FDCA) license issued to one of the accused for ayurvedic manufacturing under

Special arrangements in place for ODI

Ahmedabad: With the final of the three ODI cricket matches between India and England scheduled at Narendra Modi stadium in Ahmedabad on Wednesday, the Ahmedabad City Police and Gujarat Metro Rail Corporation (GMRC) have made special arrangements for commuters.

According to a statement on Monday, the GMRC has decided to extend the timings of the Metro train services on match day up to 12 am (midnight), with higher frequency, as against 10 pm on usual

days in Ahmedabad. This facility has not been extended to Gandhinagar. On February 12, Metro trains

will be available in Ahmedabad (From Motera to APMC and Thaltej Gam to Vastral Gam) every eight minutes. For extended hours from 10 pm to 12 am, trains will be available from Motera and Sabarmati only to other Metro stations in Ahmedabad. Further, after 10 pm, only special paper tickets will be allowed for entry from Motera and Sabarmati, which can

be purchased at various designated spots. Any ticket (QR /token) purchased for the return journey in advance from kiosks, token vending machines, ticket counters and mobile apps will not be valid after 10 pm.

Meanwhile, the Ahmedabad Traffic Police has declared the $route\,between\,\underline{\it J}anpath\,T\,iunction$ towards Krupa Residency and up to Motera T junction closed for traffic from 9 am till the time the match ends and police protection is withdrawn from the area. ENS

On way back from Vadodara with two kids, couple killed as SUV rams truck

Ahmedabad: A couple travelling from Vadodara to Ahmedabad, along with their children, was killed after their SUV rammed the backside of a truck on National Expressway-1 (NE-1) during the $wee \, hours \, of \, Monday, police \, said.$

While their 12-year-old daughter escaped unhurt, their son, 7, sustained minor injuries. Police said an FIR would be filed against the deceased SUV driver, Vishal Ganpatlal Jain, 36, for allegedly driving the vehicle "at a very high speed". The accident took place when the family was heading back to Ahmedabad in their MG Hector SUV, said police. Their car hit the back of a truck. crushing the entire front portion of the car, killing Jain and Usha on the spot, said inspector HV Raval of 'A' Division Traffic police. Raval said both the children were taken

to a local hospital for treatment.

The inspector further said that an FIR would be filed against Jain for driving the SUV at a very high speed that had led to the accident with the truck that was moving in the middle lane of the expressway. Rayal further said officials of the SUV company have also been called in to probe if any technical problem in the car could have

4 injured as SUV goes on rampage, hits six vehicles; driver booked

FOUR PEOPLE were injured, with two among them sustaining critical wounds, after an SUV driver allegedly lost control of the vehicle, went on a rampage and hit six vehicles in Ghatlodia area of Ahmedabad on Monday, said police, adding that the 38-year-old accused has been booked.

The police identified the accused as Memnagar resident Chintan Mukesh Parikh.

According to a statement from DCP Traffic (West) Neeta Desai: "Today (Monday), on 10/02/25 at 7:41 am, on the road going from Sola Cross Road to Vivekanand Circle, four-wheeler driver Chintan Mukesh Parikh... drove his Ertiga car number GJ01 WA 5408 at full speed, recklessly and negligently, endangering his own and others' lives, and hit three two-wheeler drivers, two pedestrians, and three

cars parked on the side of the road, causing minor and serious injuries to four people."

Based on the complaint from 47-year-old Priyank Indravadan Trivedi, whose father was one of those who suffered serious injuries after being hit, an FIR was filed against Parikh at Ghatlodia police station. According to the FIR, Trivedire-

ceived a phone call around 8 am Monday informing him that his father had been injured in an acci-

dent that took place between Sola crossroads and Vivekanand Circle. After reaching the spot, he saw his father had sustained injuries to his head and other parts of the body.

His father stated that he was on his two-wheeler on the way to the market when the white Ertiga SUV hit him from the back side.

The FIR, quoting the victim's father stated that "when he looked around, he saw several injured people sitting on the sides of the roads who were being tended to by bystanders, family members who had arrived at the spot or

were being taken to the hospital". The FIR stated that while Trivedi's father and another unidentified woman with grievous injuries were taken to GMERS Sola Civil Hospital, others were rushed to nearby private hospitals for treatment.

According to the police, the accused has been booked under the provisions of the BNS and the Motor Vehicles Act.
