2. The state of the company's affairs and Business Performance:

During the year under review, the Company generated a profit of Rs. 33,085.67 thousand before finance costs, depreciation, and exceptional items, compared to a profit of Rs. 14,009.06 thousand in the previous year. This profit includes lease income, which is a major source of revenue for the Company. Your Directors are actively seeking opportunities to improve performance and increase revenue in the coming year.

The Company has been focusing on lease income. In response to recent demand, a new factory shed has been offered for lease starting from April 2023. Additionally, the Company began bottling operations for another party at our Ranchi bottling plant starting in May 2023.

The Company acquired some assets, including plant and machinery and other equipment, from EIIL (which was operating our bottling plant at Rohtak on lease) from April 1, 2023. We are planning to launch a new project focused on supplying aerosol-grade LPG to various industrial customers. Additionally, the Company has completed the necessary repairs and maintenance at this plant and is now awaiting the start of operations

3. Dividend

Your directors have not recommended any dividend on Equity Shares for the year under review.

4. Transfers to Reserves

Your Board of Directors does not appropriate any amount to be transferred to General Reserves during the year under review.

5. Share Capital:

(a) Authorized Share Capital

MANAGEMENT DISCUSSION AND ANALYSIS

Industry Structure and Developments

The LPG sector is on track to achieve a compound annual growth rate (CAGR) of over 3.5% from 2022 to 2027. This growth trajectory is driven by increased demand across the Domestic, Industrial, Automobile, and Commercial sectors in India. The government's push towards cleaner fuels continues to propel this demand, reinforcing the sector's expansion.

In recent years, the number of LPG Bottling Plants in India has risen significantly, reaching a total of 202 according to the PPAC Report. This increase reflects a steady surge in LPG demand. Notably, India is projected to surpass China and become the world's largest LPG consumer for residential purposes by 2030.

Government initiatives have played a crucial role in this expansion, with LPG coverage in India now approaching 100%, a dramatic increase from 61.9% in April 2016.

Opportunities and Threats

Place: Hyderabad

Date: 23.05.2024

Opportunities: The Central Government's potential move to allow private companies to sell subsidized LPG could challenge the current monopoly held by state-owned oil marketing companies. A 5-Member Committee was established on May 30, 2019, to review LPG marketing frameworks and assess the need for policy liberalization to boost private sector participation. However, progress on this front has been slow.



Threats: While the LPG sector faces few immediate threats, the long-term outlook includes competition from Piped Natural Gas (PNG) and Electric Vehicles (EVs). Despite the complexities and significant investments required to advance PNG and EV infrastructure, including lower disposable incomes and geographical challenges, these factors could pose future risks.

Risk Management

Risk management is a core aspect of our business strategy. We identify, evaluate, and control risks through comprehensive mitigation strategies. In a highly competitive market, maintaining service revenue remains a priority.

Outlook

For FY 2023-24, our revenue continues to be bolstered by servicing large private clients and leasing facilities, including the new factory shed in Aurangabad, operational since April 2023. All company plants remain active, either through our operations, third-party bottling, or leasing, with the exception of the Jaipur LPG Bottling Plant. We are focused on enhancing revenue by introducing AEROSOL-grade LPG in 33kg cylinders under our brand "KABSONS" and 17kg cylinders for commercial and industrial use at our Rohtak plant. We anticipate significant growth in LPG demand across residential, auto LPG, commercial, and industrial segments.

Internal Financial Control and Its Adequacy

The Board has established internal financial controls that comply with the Companies Act, 2013 and Stock Exchange Listing Regulations. These controls are designed to ensure efficient business conduct, asset protection, fraud prevention, accurate accounting records, and reliable financial reporting.

Financial Performance Discussion

For FY 2023-24, the company reported a total income of Rs. 284,833.91 thousand, a substantial increase from Rs. 173,329.86 thousand in FY 2022-23. Profit after tax surged to Rs. 26,057.03 thousand, up from Rs. 7,896.82 thousand the previous year. This represents a remarkable 229.97% increase in total revenue and a 77.19% rise in net profit compared to the prior financial year.

Human Resources and Industrial Relations

Our management values employees as vital assets, focusing on their development, motivation, and retention. As of the end of the year, the company employed 22 individuals.

Report on he Financial Statements:

Qualified Opinion

We have audited the accompanying financial statements of KABSONS INDUSTRIES LIMITED("the company"), which comprise the Balance Sheet as at March 31, 2024, the Statement of Profit and Loss (including other comprehensive income), the Statement of Changes in Equity and the Statement of Cash Flows for the year ended on that date and a summary of the material accounting policies and other explanatory information (herein after referred to as "the financial statements")

In our opinion and to the best of our information and according to the explanations given to us, except for the effects of the matter described in the *Basis for Qualified Opinion* section of our report ,the accompanying financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under section 133 of the Act read with the Companies (Indian Accounting Standard) Rules, 2015, as amended, ("Ind AS") and other accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2024, the profit and total comprehensive income, changes in equity and its cash flows for the year ended on that date.

Basis for Qualified Opinion

The Company has not adopted and complied with the requirements of Ind AS-19 'Employee Benefits' in respect of the Gratuity liability which constitute a departure from the Accounting standards mentioned in the Companies (Indian Accounting Standards) Rules 2015 referred in section 133 of the Act. In view of this the liability of the company in this regard could not be ascertained. Consequently, we are unable to comment about the impact of the same on the profit for the year, income tax and shareholder's funds.

We conducted our audit of the financial statements in accordance with the Standards on Auditing (SAs) specified under Section 143(10) of the Act. Our responsibilities under those standards are further described in the Auditors responsibility for the Audit of Financial Statements section of our report. We are independent of the company in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (ICAI) together with the ethical requirements that are relevant to our audit of financial statements under the provisions of the Act and the Rules made thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion on the financial statements.

Emphasis of matter

We draw attention to Note 33.1 in the financial statements which states that the Company had decided not to provide interest on dealer/distributor depostis for the reasons explained in the said note. Our opinion is not modified in this reagard.

Key Audit Matters

Key Audit matters are those matters that in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. We have determined the matters described below to be the key audit matters to be communicated in our report.

Deferred Tax Assets

Kev Audit matter description:

The Company has not recognised deferred tax asset for deductible temporary differences and unused tax losses. As, the utilization of deferred tax assets is dependent on the company's ability to generate future taxable profits sufficient to utilize deductible temporary differences and tax losses before they expire. We determined this to be a key audit matter due to inherent limitations in estimation and uncertainty in forecasting the amount and timing of future taxable profits and the reversal of temporary differences and utilization of tax losses.

Management has supported the non -utilization of the deferred tax assets mainly with taxable income projections which contain estimates of and tax strategies for future taxable income. Changes in the industrial scenario, the business and its markets and changes in regulations may impact these projections.



Principal Audit procedures

Our audit procedures include, among others, evaluating the future estimated business projections and projected tax computations prepared by the company to assess the recognition and measurement of the current tax and deferred tax assets and liabilities and evaluate the compliance with tax legislation. We paid attention to Long-term Forecasts and critically assessed the assumptions and judgements underlying these forecasts by considering the historical accuracy of forecasts and the sensitivities of the profit forecasts. We assessed the adequacy and the level of estimation involved.

Report on Other information other than Financial statements

The Company's Board of Directors is responsible for the preparation of the other information. The other information comprises the information included in the Management Discussion and Analysis, Board's Report including Annexures to Board's Report, Corporate Governance and Shareholder's Information, but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Management's Responsibility for the Financial Statements:

The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Companies Act, 2013 ("the Act") with respect to the preparation of these Ind AS financial statements that give a true and fair view of the financial position, financial performance including other comprehensive income, cash flows and changes in equity of the Company in accordance with the Indian Accounting Standards (Ind AS) prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued there under and other accounting principles generally accepted in India.

This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the company and for preventing and detecting the frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of Ind AS financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Board of Directors is responsible for assessing the company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors either intends to liquidate the company or to cease operations, or has no realistic alternative but to do so.

The Board of Directors are responsible for overseeing the Company's financial reporting process.

Auditor's Responsibility for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

• identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control;



- obtain an understanding of internal financial controls relevant to the audit in order to design audit procedures that are appropriate in the circumstances. Under section 143(3)(i) of the Act, we are also responsible for expressing our opinion on whether the Company has adequate internal financial controls system in place and the operating effectiveness of such controls;
- evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management;
- conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern;
- evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

Materiality is the magnitude of misstatements in the Financial Statements that, individually or in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the Financial Statements may be influenced. We consider quantitative materiality and qualitative factors (i) in planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the Financial Statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

CORPORATE INFORMATION

Kabsons Industries Limited (the 'company') is a public limited company domiciled and incorporated in India under the Companies Act, 1956. The registered office of the company is located at Madhuw Vihar, 2nd Floor, Plot No.17, H.No.8-2-293/82/C/17, Road No.7, Jubilee Hills, Hyderabad, Telangana - 500033.

The company is engaged in the business of bottling andsellingLP Gas under the brand name "KABSONS". The Company's shares are listed on BSE Ltd

1. MATERIAL ACCOUNTING POLICIES

Statement of compliance

The financial statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under section 133 of the Companies Act, 2013 read with the Companies (Indian Accounting Standards) Rules, 2015, as amended from time to time and other accounting principles generally accepted in India.

1.1. BasisofPreparation and Measurement:

The financial statements have been prepared on a historical cost basis, except for financial instruments which have been measured at fair value at the end of each reporting period, as explained in the accounting policies mentioned below.

Use of estimates and judgements

The preparation of the financial statements requires that the Management to make estimates andassumptions that affect the reported amounts of assets and liabilities, disclosure of contingent liabilitiesas at the date of the financial statements and the reported amounts of revenue and expenses during thereporting period. The recognition, measurement, classification or disclosureof an item or information the financial statements is made relying on these estimates. The estimates and judgements used in the preparation of the financial statements are continuously evaluated by the Company and are based on historical experience and various other assumptions and factors (including expectations of future events) that the Company believes to be reasonable under the existing circumstances. Actual results could differ from those estimates. Any revision to accounting estimates is recognised prospectively in current and future periods.

1.2. Current Vs Non-current classifications:

Any asset or liability is classified as current if it satisfies any of the following conditions:

- i) The asset/liability is expected to be realised/ settled in the Company's normal operating cycle.
- ii) The asset is intended for sale or consumption.
- iii) The asset/liability is held primarily for the purpose of trading.
- iv) The asset/liability is expected to be realised/ settled within twelve months after the reporting period.
- v) The asset is cash or cash equivalent unless it is restricted from being exchanged or used to settle a liability for at least twelve months after the reporting date.
- vi) In the case of liability, the Company does not have an unconditional right to defer settlement of the liability for at least twelve months after the reporting date.
 - All other assets and liabilities are classified as non-current. Deferred tax assets and liabilities are classified as non-current assets and liabilities respectively.

1.3.1 Property, Plant and Equipment:

Measurement at recognition

An item of property, plant and equipment that qualifies as an asset is measured on initial recognition at cost. Followinginitial recognition, items of property, plant and equipment other than land are carried at their cost less accumulated depreciation and accumulated impairment losses. Freehold land is carried at cost of acquisition.

The cost of an item of property, plant and equipment comprises the purchase price and any cost attributable to bring the asset to its location and working condition for its intended use.Borrowing



costs relating to acquisition of property, plant and equipment which take substantial period of time to get ready for its intended use are also included to the extent they relate to theperiod till such assets are ready to put to use. Items such as spare parts, stand-by equipment and servicing equipment that meet the definition of property, plant and equipment are capitalized at cost and depreciated over their useful life.

Subsequent costs are included in the asset's carrying amount or recognized as a separate asset, as appropriate, only whenit is probable that future economic benefits associated with the item will flow to the Company and the cost of the itemcan be measured reliably. Costs in nature of repairs and maintenance are recognized in the Statement of Profit and Loss as and when incurred.

• Capital Work in Progress

Cost of assets not ready for intended use, as on the Balance Sheet date, is shown as capital work in progress. Advancesgiven towards acquisition of fixed assets outstanding at each Balance Sheet date are disclosed as Other Non-Current Assets.

Depreciation and amortization methods

- a) Depreciation is provided on Straight Line Method on the assets over the useful lives specified in Schedule II to the Companies Act, 2013.
- b) Depreciation on additions is being provided on pro rata basis from the date of such additions. Depreciation on assets sold, discarded or demolished during the year is being provided up to the date on which suchassets are sold, discarded or demolished.

Impairment

- a) Assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may notbe recoverable. An impairment loss is recognized for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less cost of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units).
- **b)** Reversal of impairment losses recognized in prioryears is recorded when there is an indicationthat the impairment losses recognized for theasset are no longer existing or have decreased.

• Derecognition

The carrying amount of an item of property, plant and equipment is derecognized on disposal or when no future economic benefits are expected from its use or disposal. The gain or loss arising from the Derecognition of an item of property, plantand equipment is measured as the difference between the net disposal proceeds and the carrying amount of the item andis recognized in the Statement of Profit and Loss when the item is derecognized.

1.3.2 Intangible Assets:

• Computer Software

Computer software ismeasured on initial recognition at cost. Following initial recognition, software is carried at its cost less accumulated amortization and accumulated impairment losses.

• Amortization Methods

The carrying amount of computer software isamortized over the useful life.

Derecognition

The carrying amount of an intangible asset is derecognized on disposal or when no future economic benefits are expectedfrom its use or disposal. The gain or loss arising from the Derecognition of an intangible asset is measured as the differencebetween the net disposal proceeds and the carrying amount of the intangible asset and is recognized in the Statement of Profit and Loss when the asset is derecognized.



Leases

The Company assesses whether a contract contains a lease, at the inception of the contract. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Company as a lessee, The Company recognizes a right-of-use asset and a lease liability at the lease commencement date. The right-of-use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the site on which it is located, less any lease incentives received. Certain lease arrangements include the option to extend or terminate the lease before the end of the lease term. The right-of-use assets and lease liabilities include these options when it is reasonably certain that the option will be exercised. The right-of-use asset is subsequently depreciated using the straight-line method from the commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. In addition, the right-of-use asset is periodically reduced by impairment losses, if any, and adjusted for certain re-measurements of the lease liability. The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Company's incremental borrowing rate. Generally, the Company uses its incremental borrowing rate as the discount rate.

The lease liability is subsequently measured at amortised cost using the effective interest method. It is remeasured when there is a change in future lease payments arising from a change in an index or rate, if there is a change in the Company's estimate of the amount expected to be payable under a residual value guarantee, or if there is a change in the lease payments or a change in the assessment of an option to purchase the underlying asset. For a lease modification that is not a separate lease, at the effective date of the modification, the lessee accounts for the lease modification by remeasuring the lease liability using a discount rate determined at that date and the lessee makes a corresponding adjustment to the right-of-use asset. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the rightof-use asset or is recorded in profit or loss if the carrying amount of the right-ofuse asset has been reduced to zero. Lease payments have been classified as financing activities in the Statement of Cash Flow. The Company has elected not to recognise right-ofuse assets and lease liabilities for short term leases that have a lease term of less than or equal to 12 months with no purchase option and assets with low value leases. The Company recognises the lease payments associated with these leases as an expense in statement of profit and loss over the lease term. The related cash flows are classified as operating activities.

Company as a lessor, Leases in which the Company does not transfer substantially all the risks and rewards of ownership of an asset are classified as operating leases. Rental income from operating lease is recognized on a straight-line basis over the term of the relevant lease. Contingent rents are recognized as revenue in the period in which they are earned. Leases are classified as finance leases when substantially all of the risks and rewards of ownership transfer from the Company to the lessee. Company didn't enter into any finance lease agreements.

1.3.3 Cash and cash equivalents:

Cash and cash equivalents include cash on hand and at bank, deposits held at call with banks, with original maturities of three months or less other short term highly liquid investments that are readily convertible to a known amount of cash which are subject to an insignificant risk of changes in value and are held for meeting short-term cash commitments.

1.3.4 Inventories

Inventories are valued at the lower cost and net realizable value.

Scrap is valued at Net realizable value.

The cost is computed on First in First Out.

Cost of Stock-in-trade, stores and packing material comprisescost of purchases and includes all other costs incurred in bringing the inventories to their present location and condition.

Net realizable value is the estimated selling price in theordinary course of business less the



estimated costsof completion and the estimated costs necessary tomake the sale.

Spare parts, stand-by equipment and servicingequipment are recognized in accordance with this IndAS-16 when they meet the definition of Property, Plantand Equipment. Otherwise, such items are classified inventory.

1.3.5 Financial Instruments

A financial instrument is any contract that gives rise toa financial asset of one entity and a financial liability orequity instrument of another entity.

Financial Assets

• Initial recognition and measurement:

All financial assets are recognized initially at fairvalue plus, in the case of financial assets notrecorded at fair value through profit or loss, transaction costs that are attributable to theacquisition of the financial asset. Transactioncosts of financial assets carried at fair valuethrough profit or loss are expensed in statement of profit or loss.

• Subsequent measurement:

For subsequent measurement, the Company classifies its financial assets into the following categories:

- (i) Amortized cost
- (ii) Fair value through profit and loss (FVTPL)
- (iii) Fair value through other comprehensive income (FVTOCI).

a) Financial Asset measured at amortized cost

Financial Assets held within a business model whose objective is to hold financial assets in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding are measured at amortized cost using effective interest rate (EIR) method. The EIR amortization is recognized as finance income in the statement of Profit & Loss.

The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees and transaction costs and other premiums or discounts) through the expected life of the financial assets, or where appropriate, a shorter period, to the gross carrying amount on initial recognition.

The company while applying above criteria has classified all the financial assets (except investments in mutual funds) at amortized cost.

b) Financial Asset measured at fair value through other comprehensive income

Financial assets that are held within a business model whose objective is achieved by both, selling financial assets and collecting contractual cash flows that are solely payments of principal and interest, are subsequently measured at fair value through other comprehensive income. Fair value movements are recognized in the other comprehensive income (OCI). Interest income measured using the EIR method and impairment losses, if any are recognized in the Statement of Profit and Loss. On derecognition, cumulative gain or loss previously recognized in OCI is reclassified from the equity to 'other income' in the Statement of Profit and Loss.

The company while applying above criteria has identified that there are no financial assets that can be classified at fair value through other comprehensive income

c) Financial Asset measured at fair value through profit and loss (FVTPL)

Financial Assets are measured at fair value through Profit & Loss if it does not meet the criteria for classification as measured at amortized cost or at FVTOCI. All fair value changes are recognized in the statement of Profit & Loss.

Investments in Mutual funds are classified as financial assets measured at FVTPL.

Impairment

In accordance with Ind AS 109, the Companyapplies expected credit loss (ECL) model formeasurement and recognition of impairmentloss on the debt instruments, that are measured at amortized cost e.g., loans, debtsecurities, deposits, trade receivables and bankbalance.



Expected credit loss is the difference betweenall contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the entity expects to receive.

The management uses a provision matrix todetermine the impairment loss on the portfolioof trade and other receivables. Provision matrices based on its historically observed expectedcredit loss rates over the expected life of thetrade receivables and is adjusted for forwardlooking estimates.

Expected credit loss allowance or reversalrecognized during the period is recognized asincome or expense, as the case may be, in the statement of profit and loss. In case of balancesheet, it is shown as reduction from the specific financial asset.

Derecognition

The Company derecognizes a financial asset when the contractual rights to the cash flows from the financial asset expire, or it transfers the contractual rights to receive the cash flows from the asset

Financial Liabilities

· Initial Recognition and Measurement

Financial liabilities are recognized initially at fair valueplus any transaction cost that are attributable to theacquisition of the financial liability except financialliabilities at FVTPL that are measured at fair value

Subsequent Measurement

a. Financial liabilities at fair valuethrough profit or loss

Financial liabilities at fair value throughprofit or loss include financial liabilitiesheld for trading and financial liabilitiesdesignated upon initial recognition as atfair value through profit or loss. Gain orlosses on liabilities held for trading are recognized in the profit or loss. The Company doesn't designate anyfinancial liability at fair value throughprofit or loss.

b. Financial liabilities at amortized cost

All financial liabilities of the Company are subsequently measured at amortized cost using the effective interest method.

Derecognition

A financial liability is derecognized when the obligation specified in the contract is discharged, cancelled or expires.

1.3.6 Revenue

Revenue from contract with customer is recognized upon transfer of control of promised products or services to customers on complete satisfaction of performance obligations for an amount that reflects the consideration which the Company expects to receive in exchange for those products or services. Revenue is measured based on the transaction price, which is the consideration, adjusted for discounts and other incentives, if any, as per contracts with the customers. Revenue also excludes taxes or amounts collected from customers in its capacity as agent.

Sale of goods:

Revenue is recognized when the significantrisks and rewards of ownership of goods havepassed to the buyer. Amounts disclosed as revenue arenet of returns, tradeallowances, rebates,GST.

Rendering of Services

Revenue from services rendered is recognised when the work is performed and as per the terms of agreement.

• Interest / Dividend

Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition. Dividend income is recognized when right toreceive is established.

1.3.7 Prior period items

In case prior period adjustments are material in nature, the Company prepares the restated financial statements as required under Ind AS 8 - "Accounting Policies, Changes in Accounting Estimates



and Errors". Immaterial items pertaining to prior periods are shown under respective items in the Statement of Profit and Loss

1.3.8 Income taxes

Income tax expense for the year comprises current tax and deferred tax.lt is recognized in the Statement of Profit and Loss except to the extentit relates to a business combination or to an item which is recognized directly in equity or in other comprehensive income.

Current tax is the expected tax payable/receivable on the taxable income/loss for the year using applicable tax rates at the Balance Sheet date, andany adjustment to taxes in respect of previous years. Interest expense if any, related to income tax are included incurrent tax expense.

Deferred tax Deferred tax assets and liabilities are recognised for deductible and taxable temporary differences arising between the tax base of assets and liabilities and their carrying amount, except when the deferred tax arises from the initial recognition of an asset or liability in a transaction that is not a business combination and affects neither accounting nor taxable profit or loss at the time of the transaction

Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carry forward of unused tax credits and unused tax losses can be utilised. Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the year when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the reporting date.

1.3.9 Provisions and contingent liabilities

Provisions are recognized when there is a presentlegal or constructive obligation that can be estimated reliably, as a result of a past event, when it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

Provisions are reviewed at each reporting date andadjusted to reflect the current best estimate. If it is nolonger probable that an outflow of economic resourceswill be required to settle the obligation, the provisions are reversed. Where the effect of the time value ofmoney is material, provisions are discounted using acurrent pre-tax rate that reflects, where appropriate, the risks specific to the liability. When discounting issued, the increase in the provisions due to the passageof time is recognized as a finance cost.

Contingent liabilities are disclosed when there is a possible obligationarising from past events, the existence of which will be confirmed only bythe occurrence or non-occurrence of one or more uncertain future eventsnot wholly within the control of the Company or a present obligation thatarises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made.

1.3.10 Earnings per share

The Company presents basic and diluted earnings pershare ("EPS") data for its ordinary shares. Basic EPS iscalculated by dividing the profit or loss attributable toordinary shareholders of the Company by the weightedaverage number of ordinary shares outstanding duringthe period. Diluted EPS is determined by adjusting theprofit or loss attributable to ordinary shareholders and the weighted average number of ordinary sharesoutstanding for the effects of all dilutive potentialordinary shares, which includes all stock options grantedto employees.

1.3.11Functional and Reporting Currency:

The Company's functional and reporting currency is Indian National Rupee.

Initial Recognition:

Foreign currency transactions are recorded in thereporting currency, by applying to the foreign currency amounts the exchange rate betweenthe reporting currency and the foreign currencyat the date of the transaction.

. Conversion on reporting date:

Foreign currency monetary items are reportedusing the closing rate with reference to RBI ratenon-monetary itemsthat are measured in terms of historical costing a foreign currency is translated using the exchange rates at the dates of the initialtransactions.



• Exchange Differences:

Exchange difference arising on the settlementof monetary items or on reporting monetaryitems of Company at rates different from thoseat which they were initially recorded during theyear or reported in previous financial statements are recognized as income or as expenses in theyear in which they arise.

1.3.11 Employee Benefits

• Defined Contribution Plan

Employer's contribution to Provident Fund/Employee State Insurance which is in the natureof defined contribution scheme is expensed offwhen the contributions to the respective fundsare due. There are no other obligations otherthan the contribution payable to the fund.

• Defined Benefit Plan

a. Gratuity

Gratuity liability is definedbenefit obligation. Such liability is provided only for employees who have completed 5 years of continuous service as per the provisions of the Payment of Gratuity Act, 1972.

b. Compensated absences

Compensated absences which are defined benefit obligation are provided for based on number of leaves outstanding as on balance sheet date according to the policy of the company.

1.3.12 Dividends

Annual dividend distribution to the shareholders is recognized as a liability in the period in which the dividend is approved by the shareholders in Statement of changes in Equity. Any interim dividend paid is recognized on approval by Board of Directors.

1.3.13 Investment property

- i. Assets which are held for long-term rental yields or for capital appreciation or both, are classified as Investment Properties. Investment properties are measured initially at cost, including transaction osts. Subsequent to initial recognition, investment properties are stated at cost less accumulated depreciation and accumulated impairment loss, if any. The Company has elected to regard previous GAAP carrying values of investment properties as deemed cost at the date of transition to Ind AS.
- ii. The Company depreciates investment properties over their estimated useful lives, as specified in Schedule II to the Companies Act, 2013.
- iii. Investment properties are derecognised either when they have been disposed off or when they are permanently withdrawn from use and no future economic benefit is expected from their disposal. The difference between the net disposal proceeds and the carrying amount of the asset is recognised in Statement of Profit and Loss in the period in which the property is derecognized.

33.2.7 Financial Risk Management Objectives and Policies

The company is exposed to financial risks arising from its operations and the use of financial instruments. The key financial risks include interest rate risk, foreign currency risk, market risk, credit risk and liquidity risk. The company has a risk management policy which not only covers the foreign exchange risks, but also other risks associated with financial assets and liabilities such as interest rate risks and credit risks. The risk management framework aims to:

- 1. Create a stable business planning environment by reducing the impact of currency and interest rate fluctuations on the company's business plan.
- 2 .Achieve greater predictability to earnings by determining the financial value of the expected earnings in advance.

The following sections provide the details regarding the Company's exposure to the financial risks associated with financial instruments held in the ordinary course of business and the objectives policies and processes for the management of these risks.

(i) Market Risk:

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market prices comprise three types of risk currency rate risk, interest rate risk and other price risks such as equity risk. Financial instruments affected by market risk include deposits and mutual funds.

a. Interest Rate Risk

Interest rate risk is the risk that the fair value or future cash flows of the Company and the Company's financial instruments will fluctuate because of changes in market interest rates. Since the Company has no interest-bearing debts, exposure to interest rate risk is minimal.

b. Foreign Currency Risk

Currency risk is the risk that the value of a financial instrument will fluctuate due to changes in foreign exchange rates. Currency risk arises when transactions are denominated in foreign currencies.

The Company has no transactional currency exposures arising from goods supplied or received that are denominated in a currency other than the functional currency. Hence exposure to foreign currency risk is Nil.

c. Other price risk

Other price risk is the risk that the fair value or future cash flows of the Company's financial instruments will fluctuate because of changes in market prices (other than those arising from interest rate risk or currency risk) whether those changes are caused by factors specific to the individual financial instrument or its issuer or by factors affecting all similar financial instruments traded in the market.

(ii) Credit Risk:

Credit risk is the risk that counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss.
