As informed by the Resolution Professional of the Company vide his email dated 15.11.2024, we are submitting herewith following.

**SUBJECT: INTIMATION OF THE EXTENSION OF THE ANNUAL GENERAL MEETING OF THE COMPANY FOR THE FINANCIAL YEAR ENDED ON MARCH 31, 2024**

As informed earlier that Hon'ble Adjudicating Authority, i.e., National Company Law Tribunal, Chandigarh Bench admitted the Company Petition i.e. C.P. (IB) No. 291/Chd/Chd/2018 filed by the Financial Creditor, Edelweiss Asset Reconstruction Company Limited, on 22.12.2023, initiating Corporate Insolvency Resolution Process under Insolvency & Bankruptcy Code, 2016 (hereinafter referred to as "Code") against M/s Winsome Yarns Limited ("Corporate Debtor") and appointed Mr. Sanjay Gupta as the Interim Resolution Professional. Thereupon the members of the Committee of Creditors ("CoC") in its has approved appointment of M/s ARCK Resolution Professionals LLP, Insolvency Professional Entity, as Resolution Professional in place of erstwhile IRP. The appointment of M/s ARCK Resolution Professionals LLP, Insolvency Professional Entity, was confirmed as Resolution Professional vide Order of Hon'ble NCLT passed on 14.03.2024.

Since initiation of CIRP, the powers of the Board of Directors are suspended and vests with the IRP/RP as per the provisions of Section 17 and Section 23 of the Insolvency and Bankruptcy Code, 2016. Furthermore, the Resolution Professional, for the purpose of making necessary compliance, in pursuant to Ministry of Corporate Affairs General Circular No. 8/2020 dated 06.03.2020, has filed an application for extension the time period of Annual General Meeting of the company, to be held for Financial Year 2023-24, through e-Form GNL-2.

The said form being filed by the Resolution Professional has been approved and taken on record by the Registrar of Companies, Chandigarh which in term considered as an approval of the application being filed by the Company requesting for the extension of holding and calling Annual General Meeting for period of 3 months i.e. upto December 31, 2024.
