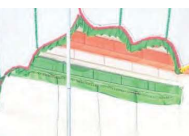

The 2024 Paris Olympic Games have marked a watershed moment for China as the nation achieved a series of historic milestones across a wide range of sports. These achievements not only underscored China's growing competitiveness on the global stage but also signal a powerful legacy for future generations of Chinese athletes.

In traditional strongholds like diving and table



tennis, Chinese athletes delivered an unprecedented performance, sweeping eight and five gold medals respectively across all categories. This rare feat at a single Olympics highlights the country's continued dominance in these sports, where precision and consistency are key.

The Chinese swimming team also made history, wrapping up their campaign in Paris with a record-breaking 12 medals — two golds, three silvers, and seven bronzes. This marks the highest number of medals ever secured by the Chinese swim team in Olympic history, signalling a significant leap forward in a sport where China has been striving to make its mark.

One of the most noteworthy achievements came in tennis, where 21-year-old Zheng Qinwen became the first Asia-born player to win a gold medal in the Olympic singles event. Her victory is particularly remarkable as it breaks the traditional dominance of Western players in tennis, showcasing China's rising talent in a sport that has been relatively new to the country's roster of strengths.

It also signifies a new era of Chinese sportsmanship, where the nation is not just a powerhouse in a few selected sports but a formidable competitor across a broader spectrum.

It was shocking when ace India defender Amit Rohidas was shown red card in the Olympic quarter-final match against Great Britain. Rohidas, an important cogwheel in defence and feeding forwards in their surge towards opponent's goalmouth was sadly missed in the semifinal against Germany. However, in the play-off against Spain for the Bronze medal, skipper Harmanpreet, Srijesh and Amit are to be lauded for their resilience and grit to overcome a mounting challenge from Spain in the closing stages of the game.



earlier earned by Punjab. Odisha Not just the hockey team's sponsor, Odisha has created a whole eco system for the sport to be revived. Odisha's involvement with Indian hockey started in 2018 when the Naveen Patnaik-led government stepped in as the official sponsor of the Indian hockey teams. Not to lag behind, Mohan Charan Majhi, Chief Minister has extended the sponsorship to 2036 as state's long-term commitment to the sport.

Congratulating the Indian team, Odisha CM Mohan Charan Majhi announced a reward of Rs. 15 lakh for each player in the squad. He also announced an additional Rs. 4 crore for state's player Amit Rohidas, besides announcing that a reward of Rs. 10 lakh has been allocated for the staff of the Indian men's hockey team. Joining the celebrations after the Harmanpreet Singh-led side defeated Spain 2-1 in a nail-biting bronze medal play-off, former CM Patnaik termed it a historic moment not just for the state but for the country. "May this bring back the halcyon days for hockey, bringing more and more laurels for the country," Patnaik posted on social media.

In India's journey to salvage respect in hockey at international level, the role of coach Craig Fulton proved fruitful. Fulton oversaw some massive changes which have reflected in their result.

After the Indian hockey team's remarkable performance at Paris, capturing second consecutive Olympic bronze medal ushered the return of glory days for the sport in the country. Kudos to Odisha in becoming the home of Indian hockey, an epithet

India can hope for Aussie Test series hatrick: Shastri

Mumbai, Aug 15: India can make a hatrick of wins. This statement isn't just a hopeful declaration; it's a sentiment echoed by cricket greats and fans alike as the Indian cricket team prepares for yet another showdown in the Border-Gavaskar Trophy against Australia.

With two consecutive series victories on Australian soil, the team is on the brink of something historic — securing three back-to-back Test series wins against Australia in their own backyard.

Ravi Shastri, a former coach and a stalwart of Indian cricket, firmly believes that his former team can continue their recent dominance. The anticipation surrounding the series is palpable, with Australia still smarting from their last two defeats and hungry for revenge. Shastri knows that the Australians, led by Pat Cummins, will be formidable opponents, but he is confident in India's ability to rise to the occasion.

Australia, having last claimed the Border-Gavaskar Trophy with a 2-0 win on home soil in 2015, is eager to regain their grip on the coveted prize. The upcoming five-match series, set to begin in November, is already being billed as one of the most eagerly awaited contests in recent memory.

Australian legend Ricky Ponting has predicted a 3-1 victory for his side, but Shastri is quick to remind everyone of India's resilience and determination.

Para badminton star Bhagat suspended for doping violations

Bengaluru, Aug 15: In a major blow to India's Paralympic ambitions, Pramod Bhagat, the Paralympic badminton champion, who clinched gold at the Tokyo 2020 Games, has been handed an 18-month suspension by the Badminton World Federation (BWF).

This ruling means Bhagat will miss the Paris 2024 Paralympic Games.

The suspension comes after Bhagat was found in violation of the BWF's anti-doping regulations, specifically for committing three whereabouts failures within a 12-month period. The ruling was initially made on March 1, 2024, by the Court of Arbitration for Sport's (CAS) Anti-Doping Division.

Despite Bhagat's appeal to the CAS Appeals Division, hoping to overturn the suspension, the appeal was dismissed on July 29, 2024, confirming the initial decision. As a result, his period of ineligibility is now in effect, leaving India's Paralympic badminton contingent without one of its most decorated athletes.

Pramod Bhagat, who competes in the SL3 category, has been a beacon of hope and inspiration for millions, especially after his triumph in Tokyo.
