Sub: Clarification on share price movement

With reference to your office email reference no; L/SURV/ONL/PV/AV/2024-2025/81 dated 05th June 2024 seeking clarification with respect to significant movement in the price of the security of our Company, we would like to inform you that our company maintains robust internal controls and corporate governance practices to monitor and prevent any unauthorized dissemination of information. We hereby confirm that our company does not hold any unpublished price-sensitive information (UPS) that could have contributed to the volume of shares traded.

On June 1st, 2024 (Saturday), the Company submitted a disclosure to BSE under Regulation 30 of the SEBI (LODR) Regulations, 2015, informing about a business update titled "**Design, development, and delivery of an HPC SoC based on 5nm technology**" with a contract value of **Rs 509.37 crore (Rs 568 crore including Re-spin)**, we believe that the increase in trading volume may be attributed to the positive market reaction to our recent business release. The details of the announcement were disseminated to the stock exchanges and made publicly available, ensuring transparency and compliance with all regulatory requirements. (Regulation 30 of SEBI (LODR))

The movement in the Company's share price is purely due to market conditions and appears to be market-driven, over which the Company has no control.

The Company reiterated its adherence to the requirements laid down in Regulation 30 of SEBI (LODR) Regulations, 2015, and will continue to keep the stock exchanges duly informed with timely disclosures as per the SEBI (LODR) Regulations.
