Sub: Intimation pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations")- Update on tax litigation of subsidiary company.

This is with reference to the earlier intimation filed by the Company dated 20 April 2024, informing about the appeal filed by Aditya Birla Sun Life Insurance Limited (ABSLI), a subsidiary of Aditya Birla Capital Limited (the Company), before Commissioner of Income Tax (Appeals) against the assessment order cum demand notice issued by the Assessing Officer (AO) relating to Assessment Year (AY) 2020-21 of Rs. 545,56,18,360/-.

In continuation to above, ABSLI was asked to make part payment of Rs. 10,91,12,367/- out of the above outstanding demand of Rs.545,56,18,360/-, to which ABSLI has requested to adjust the amount from the refund determined for AY 2024-25.

Accordingly, the Assessing Officer vide its order dated 30 January 2025 (received by the Company on 31 January 2025), has stayed outstanding demand of Rs. 5,34,65,05,993/- subject to necessary undertakings by ABSLI and review by the Assessing Officer.

We request you to take an update of the above on your records.
