Sub: Allotment of Shares under Company Employee Stock Option Schemes
Ref: Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

The Stakeholders Relationship Committee of the Board of Directors of the Company at its Meeting held today, has approved an allotment of 1,04,224 equity shares of Rs.10/- each, being the exercise of 7,310 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013), 32,625 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014) and 64,289 equity stock options under the Employee Stock Option Scheme, 2022 (ESOS 2022). Out of 1,04,224 equity shares allotted in the meeting, 60,000 equity shares were allotted to Mr. Subramanian Sundaresan, Chief Executive Officer.

Consequent to this the paid-up equity share capital has increased from 3,70,24,524 equity shares of Rs.10/- each to 3,71,28,748 equity shares of Rs.10/- each. - ii) The National Stock Exchange of India Limited vide their letter No.NSE/LIST/252668-7 dated 13th October, 2014 for ESOS 2013, letter No.NSE/LIST/252389-U dated 9th October, 2014 for ESOS 2014 and letter No. NSE/LIST/32266 dated 01st September, 2022 for ESOS 2022.

The Company shall apply for the listing and trading permission shortly.
