Dr. Habil Khorakiwala bestowed Lifetime Achievement Award by Integrated Health and Wellbeing Council in Dubai

The Council acknowledged his unparalleled contributions towards unwavering commitment to innovation, patient care and integration of global standards setting a new benchmark in the industry. one year and is also being evaluated in a clinical study involving patients with documented meropenem-resistant infections.

Dr. Habil Khorakiwala is also ex-President of FICCI & has played an important role in India's bilateral relations & nation building effort.

On his behalf, the award was accepted by Dr. Huzaifa Khorakiwala (Executive Director of Wockhardt and CEO of Wockhardt Foundation) at the 10th edition of Integrated Health and Wellbeing Summit & Global Health Leaders Awards held on 21st September, 2024, at the Hyatt Regency in Deira Dubai.
