**Cupid Limited gets Female Condom Variant UNFPA Prequalified to Supply  
100% of Upcoming South Africa Tender**

**Mumbai, January 24<sup>th</sup> 2025:** Cupid Limited, India's premier manufacturer and brand of male and female condoms, water based personal lubricants, IVD kits, deodorants, perfumes, almond hair oil, body oils, petroleum jelly and other FMCG Products has yesterday received the prequalification for its Brown Caramel Female Condom Variant from the UNFPA.

This Prequalification makes Cupid Limited eligible to supply 100% of the Contract for Female Condoms in the upcoming RT75-2025 South African Government Tender which is for a duration of 5 years with bids closing on 31st January 2025.

Earlier Cupid Limited had been eligible to supply 75% of the Contract for Female Condoms in previous tenders which were for shorter durations of 3 years at a time.
