We refer to our letter dated May 14, 2024 informing about the decision of the Board of Directors of the Company approving the scheme of arrangement between the Company ("Siemens Limited / Company / Demerged Company") and Siemens Energy India Limited ("SEIL / Resulting Company") (a wholly owned subsidiary of SL, which was incorporated on February 7, 2024) and their respective shareholders and creditors ("Scheme"), providing for the demerger of the Company's Energy Business (as defined in the Scheme) to SEIL in compliance with Sections 230 to 232 and other applicable provisions of the Companies Act, 2013.

The Company vide letters dated September 18, 2024 and September 19, 2024 has informed about receipt of observation letter from BSE Limited with 'no adverse observations' and observation letter from National Stock Exchange of India Limited with 'no objection', respectively, in relation to the Scheme.
