This is in furtherance to the intimation by TVS SCS Global Freight Solutions Limited (TVS SCS GFS), a wholly owned subsidiary of TVS Supply Chain Solutions Limited ("Company"), dated January 12, 2024, on tax demand of ₹ 55.69 crores, Penalty of ₹ 5.56 crores and Interest of ₹ 57.67 crores from Assistant Commissioner (ST), Valluvar Kottam Assessment Circle, Commercial Tax Department, Government of Tamil Nadu ("Order") under Central Goods and Services Tax ("CGST") Act, 2017.

TVS GFS challenged the same before Hon'ble High Court of Judicature at Chennai and as per Hon'ble Court's direction to the CGST department, reassessment has been completed and issued the revised order with **NIL** tax demand.
