# ● MOUNTING SCRUTINY OVER CHILD SAFETY Insta tightens teen use norms; parents get more control

**INSTAGRAM IS CHANGING** the default privacy settings for many US teenagers, part of an effort to keep them safer and give parents more control over how their kids interact online.

The new settings will make teen accounts private by default, limit who those users can send private messages to, and put teens in the "most restrictive" tier when it comes to viewing sensitive content. That means the app will block teens from seeing sensitive photos and videos, including posts that show people fighting or certain cosmetic procedures.

These more restrictive settings will be turned on automatically for all Instagram users under 18 years of age, the company said on Tuesday, though 16- and 17-year-olds can change them on their own. If a younger teen tries to evade the new curbs by changing their birthday, Meta said it will use artificial intelligence technology to try and "proactively find these teens and place them" into more restrictive accounts.

The restrictions for those under 16 can be relaxed if a parent provides permission via their own Instagram account.

The widespread changes come after years of criticism that Instagram, owned by Facebook parent Meta Platforms, has failed to adequately protect young people online. Meta was sued last year by a group of over 30 US states alleging its apps are harming young people, and CEO Mark Zuckerberg appeared at a congressional hearing earlier

# PhonePe tops 50% UPI market share by value

GPay retains second spot in Aug; Paytm's share slips further

**WALMART-OWNED PHONEPE** clocked in 7.23 billion UPI transactions worth ₹10.33 lakh crore during August, which translated to a leading market share of 48.4% by volume and 50.1% by value, according to the latest data from the National Payments Corporation of India (NPCI).

In July, PhonePe's market share by volume stood at 48.3% and that by transaction value was at 49.8%.

Google Pay continues to remain at the second spot with a market share of 37.3% by volume and 36% by value, while Paytm's market share by volume slipped to 7.2% from 7.8% a month ago. In terms of value,

Paytm's market share came down to 5.5% from 5.9% in July. In total, Unified Payments Interface (UPI) transactions in August rose 3.6% month-on-month to 14.96 billion and worth ₹20.61 lakh crore.

Among total transactions, P2P or peer-to-peer UPI transactions constituted 37.6% in volume, while P2M or peer-to-merchant transactions were at 62.4%. Besides the top three players, transaction volumes also inched

higher for Navi, Cred, and FamPay. Sachin Bansal's Navi surpassed Amazon Pay in terms of transaction volume, while Y-Combinator-backed FamPay surpassed ICICI Bank.

As per the latest data, Navi registered 88.71 million UPI transactions, while Amazon Pay recorded 70.72 million. However, in terms of transaction value, Amazon Pay recorded ₹7,744 crore, higher than ₹4,651 crore on Navi.

FamPay's UPI transaction volume was 57 million, higher than the 51 million recorded on the ICICI Bank app. Kunal Shah's Cred, which holds the fourth-highest market share by transaction volume, has recorded 147 million transactions, about 3% higher than July.

# Asian Champions Trophy: India bag record fifth title

Hulunbuir (China), Sept 17

**A DETERMINED INDIA** claimed their fifth Asian Champions Trophy title with a fighting 1-0 victory over hosts China here on Tuesday, completing a display of absolute dominance in the tournament in which they won all their matches.

Defender Jugraj Singh scored a rare field goal as the defending champions toiled hard before getting the better of their opponents. It was not easy for the Harmanpreet Singh-led India as they failed to break the Chinese defence in the first three quarters.

Eventually, Jugraj broke the deadlock in the 51st minute to hand the Paris Olympics bronze medallists the win against a resolute Chinese side, which was playing in only its second international tournament final.

Before this, China's only appearance in the final of an

international tournament was in 2006 Asian Games, where they finished second-best after losing 1-3 to Korea. Earlier in the day, Pakistan defeated Korea 5-2 to bag the third spot in the six-team competition.

India started the contest as favourites, having defeated China 3-0 in their opening league game, but the final turned out to be a very close affair.

INDIAN INSTITUTE OF Management (IIM), Bangalore, grabbed the third position in Bloomberg Businessweek's rankings of top B-schools across the Asia-Pacific region for 2024-25, with an overall score of 73.6.
