ii) Allotment of **14,60,000** (Fourteen Lakhs and Sixty Thousand) **Warrants** (convertible into Equity Shares) of face value of Rs. 10/-per equity, at an issue price of Rs. 500/- (Rupees Five Hundred Only) including premium of Rs. 490/- (Rupees Four Hundred and Ninety Only) per warrant, out of which the company has received 25% i.e. Rs. 125/- (Rupees One-Hundred Twenty-Five Only) each as warrant subscription money for an aggregate amount of Rs. 18,25,00,000/- (Rupees Eighteen Crore Twenty-Five Lakh Only).
