NOTICE OF 27TH ANNUAL GENERAL MEETING, E-VOTING AND BOOK CLOSURE

Notice is hereby given to the members of E-Land Apparel Limited ('Company') pursuant to provisions of section 96 of the Companies Act, 2013 ('Act') read with Companies (Management and Administration) Rules, 2014 as amended ('Rules'), that the 27th Annual General Meeting of the Company ('AGM') to be held on Friday, September 20, 2024 through VC/OAVM at 11:00 AM (I.S.T.) to transact the business as set out in the notice of AGM.

The Ministry of Corporate Affairs vide General Circular No. Circular No. 20/2020 dated May 05, 2020 and Circular no. 02/2021 dated January 13, 2021 read with Circular Nos. 14/2020 and 17/2020 dated April 06, 2020 and April 13, 2020 respectively, General Circular No.21/2021 dated December 14, 2021, General Circular No.10/2022 dated December 28, 2022 and General Circular No.09/2023 dated September 25, 2023 (collectively referred to as 'MCA Circulars') and Securities and Exchange Board of India (SEBI) vide its Circular No. SEBI/HO/CFD/CMD/DIR/P/2020/79 dated May 12, 2020, Circular No. SEBI/HO/CFD/CMD/DIR/P/2021/11 dated January 15, 2021, Circular No. SEBI/HO/CFD/PoD-2/P/DIR/2023/4 dated January 05, 2023 and SEBI/HO/CFD/CFD-POD-2/P/DIR/2020/167 dated October 07, 2023 (collectively referred to as 'SEBI Circulars') has permitted companies to hold Annual General Meetings ('AGM') through Video Conferencing ('VC') or Other Audio Visual Means ('OAVM'), without physical presence of the Members at a common venue and provided relaxation from despatching of physical copy of Annual Report upto September 30, 2024.

The Company has sent electronic copies of Annual Report along with the Notice of AGM on Tuesday, August 27, 2024 to those shareholders whose email IDs are registered with the Company/Depository Participants as on the cut-off date i.e. August 23, 2024. The Notice of AGM along with Annual Report for the financial year 2023-24, will be available on the website of the Company at www.elandapparel.com, on the website of Stock Exchanges i.e. BSE Limited at www.bseindia.com and on the website of National Securities Depository Limited ('NSDL') at www.evoting.nsdl.com. Members holding shares in physical form and who have not registered their email addresses with the Company/Company's RTA, can get the same registered and obtain Notice of the 27th AGM of the Company along with Annual Report for the financial year ended March 31, 2024 and/or login credentials for joining the 27th AGM of the Company through VC/OAVM facility including e-voting, by sending scanned copies of following documents by email to the Company's RTA at investor@sgsharcourtne.com or the Company at investor@elandapparel.com:

- a. A duly signed and completed Form ISR-1
- b. A signed request letter mentioning your name, folio number and complete address, mobile number and email address to be registered.
- c. Self-attested scanned copy of the Pan Card, and
- d. Self-attested scanned of any document (such as Aadhar card, Driving License, Election Identity Card, Passport) in support of the address of the Members as registered with the company.

Members holding shares in dematerialized form are requested to register / update their email addresses with the relevant Depository Participants.

Members holding shares in physical form or dematerialized mode, as on cut-off date i.e., Friday, September 13, 2024, being the cut-off date may cast their vote electronically on the resolutions set forth in the Notice of AGM through electronic system of NSDL ("remote e-voting"). All the members are hereby informed that:

1. The business, as set out in the notice of AGM, may be transacted through remote e-voting or e-voting system at the AGM.
2. The remote e-voting period shall commence on Tuesday, September 17, 2024 at 9:00 A.M and shall end on Thursday, September 19, 2024 at 5:00 P.M.
 1. The cut-off date for determining eligibility to vote by remote e-voting or e-voting at the AGM shall be Friday, September 13, 2024.
 2. Any member who acquires shares of the company and becomes the member of the company after despatch of notice and holding shares as of cut-off date i.e., Friday, September 13, 2024 may obtain login ID and password by sending a request at evoting@nsdl.co.in.
 3. Only those Members/ shareholders, who will be present in the AGM through VC/OAVM facility have not casted their vote on the Resolution through remote E-Voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system in the AGM.
 4. Members who have voted through Remote e-voting will be eligible to attend the AGM. However, they will not be eligible to vote at the AGM.
 5. The detailed procedure and instruction for remote e-voting and e-voting during the AGM are given in the notice of AGM.
 6. Members may note that:
 - The remote e-voting shall be disabled by NSDL after the e-voting closure date and time for voting and once the vote on a resolution is cast by member, the member shall not be allowed to change it subsequently.
 - The facility for voting at the AGM shall be made available by the NSDL.
 - The person whose name is recorded in the register of members or in register of beneficial owners maintained by the depositories as on the cut-off date shall only be entitled to avail the facility of remote e-voting as well as voting in the AGM.
 - The Notice of the AGM along with the Annual Report is made available on the website of the company at www.elandapparel.com and on the website of the National Securities Depository Limited (NSDL) at www.evoting.nsdl.com.
 7.
