Sub: Compliance with Regulation 44(3) of the Securities and Exchange Board of India (Listing Regulations and Disclosure Requirements) Regulations, 2015- Details of the Voting Results of the 34th Annual General Meeting of the Company.

We wish to inform you that the 34th Annual General Meeting ("AGM") of the members of V.R Woodart Limited was held on Wednesday, September 25, 2024 at 10.30 a.m. (IST) through video conferencing mode.

The Meeting was held in compliance with the applicable provisions of the Companies Act, 2013 ("Act") and the Rules made thereunder, the SEBI (Listing Regulations and Disclosure Requirements) Regulations, 2015 ("the SEBI Listing Regulations"), the General Circulars issued by the Ministry of Corporate Affairs and the circulars issued by the Securities and Exchange Board of India.

As per the provisions of the Act and the SEBI Listing Regulations read with the aforesaid MCA Circulars, the Company had provided facility of remote e-voting to the shareholders to enable them to cast their vote electronically on the Resolutions proposed in the Notice of the 34th AGM. The remote e-voting was open from Saturday, September 21, 2024 at 9.00 a.m. (IST) to Tuesday, September 24 2024, at 5.00 p.m. (IST).

Pursuant to the provisions of Section 107 of the Act, there was no voting on the resolutions by show of hands at the AGM and voting at the AGM was therefore conducted through e-voting.

The Board of Directors had appointed Mr. Ankit Parekh, Proprietor M/s A. D Parekh & Associates, Practicing Company Secretaries, as a Scrutinizer for e-voting and e-voting process at the AGM. Mr. Parekh has carried out the scrutiny of all the votes cast through remote e-voting and e-voting conducted at the AGM and has submitted his Report on September 26, 2024. Accordingly, all the Resolutions as set out in the Notice of 34th AGM have been duly approved by the shareholders with requisite majority.





Our responsibility as a scrutinizer for the remote e-voting process prior to AGM and e-voting process at the AGM is restricted to ensure that both the e-voting processes are conducted in a fair and transparent manner and to make a Scrutinizer's Report of the votes cast "in favour" or "against" on the resolutions contained in the notice of 34th AGM, based on the reports generated from the e-voting platform / system provided by the National Securities Depository Limited (NSDL) the authorized agency to provide e-voting facilities, engaged by the Company.

SEBI Circular were duly sent to the Members of the Company through electronic mode to those Members whose email addresses were registered with the Company / Depositories, in compliance with the aforesaid MCA and SEBI Circulars. The Members of the Company holding shares on the record date ("Cut off" date) i.e. 18th September, 2024 were entitled to vote on the resolutions as set out in the notice of said AGM. In this regard, we hereby submit our report as under:

- 1. The Company had availed the e-voting facility offered by National Securities Depository Limited (NSDL), for conducting the remote e-voting prior to the AGM and e-voting during the AGM by the Members of the Company.
- The remote e-voting period prior to the AGM remained open from Saturday, 21st September, 2024 (9.00 a.m. IST) to Tuesday, 24th September, 2024 (5.00 p.m. IST) ("Remote E-voting period").
- 3. The Company had also provided e-voting facility to the Members present / logged-in at the AGM through VC and who had not cast their vote earlier. The members were allowed to cast their vote up to 15 minutes after the conclusion of the 34th AGM. NSDL e-voting platform was disabled thereafter.
- 4. We have received a complete record of votes cast through electronic mode during the remote e-voting period and votes cast during and upto 15 minutes after the closure of the AGM held on 25th September, 2024, from NSDL e-Voting System, the agency appointed for providing and supervising electronic platform. The votes cast were unblocked on 25th September, 2024 at 11.25 a.m. (IST) in the presence of two witnesses, Mr. Bhaskar Jadhav and Ms. Kinjal Parmar who are not in the employment of the Company and who have signed below in confirmation of the votes being unblocked in their presence.




