We wish to inform you that the Nomination and Remuneration Committee at its meeting held on July 18, 2024 (Grant Date) has approved the grant of 18,48,700 stock options convertible into 18,48,700 equity shares of Rs. 10/- each to the eligible employees in terms of the Employee Stock Option Plan 2018 of the Bank (ESOP 2018) at an Exercise Price of Rs. 243.85/- per option being the latest available closing price on July 16, 2024, i.e. previous trading day prior to the Grant Date on National Stock Exchange of India Limited being the Stock Exchange which recorded the higher trading volume.

These options will vest with a percentage of 30%, 30% and 40% at the end of the first, second and third year respectively and are exercisable within a period of five years from the date of vesting. Details of the same is enclosed in **Annexure I**.

Total number of shares covered by these options: Nomination and Remuneration Committee at its meeting held on July 18, 2024 (Grant Date) has approved the grant of 18,48,700 stock options convertible into 18,48,700 equity shares of Rs. 10/- each to the eligible employees in terms of the ESOP 2018.
4. Pricing formula : Exercise Price is the latest available closing price on the previous trading day prior to the Grant Date on the Recognized Stock Exchange which records the higher trading volume. In line with the same, the Exercise Price is Rs. 243.85 per option being the latest available closing price on July 16, 2024 i.e. previous trading day prior to the Grant Date on National Stock Exchange of India Limited being the Stock Exchange which recorded the higher trading volume.
5. Options vested : These options will vest after one year with a percentage of 30%, 30% and 40% at the end of the first, second and third year respectively.
6. Time within which option may be exercised : Within a period of five years from the date of vesting subject to other terms and conditions provided in the ESOP 2018.
