Modi is set to inaugurate and lay the foundation stone of mul-tiple infrastructural and develop-ment projects, including a 1.5 kilometer walkway from the parking area to the SoU, a trauma centre in Kevadia for emergencies. He will also lay the founda-tion stone of the much-delayed Museum of Royal kingdoms, which is expected to showcase the history of 562 princely states that signed the treaty of accession

A SEVEN-year-old boy was al-legedly mauled to death by a leop-ard in Surat district Monday night, said forest department officials, adding that the animal was

adding that the animal was caught on Tuesday morning. The victim, identified as Ajay Valvi, was playing outside when he was attacked by the big cat, said the officials.

According to the information shared by the Surat district forest

department officials, for the last few days, a group of farm labour-ers from Maharashtra's Nandurbar district had been working in agricultural fields in Ushker village of Mandvi taluka. The officials said that the labour-ers used to stay in the temporary tents mut unit be came fields aftents put up in the same fields af-ter work. One of the labourers,
