Fillip to MSMEs

India and the US on Tuesday signed a landmark MoU for cooperation in the MSMEs sector, to enable MSMEs of the two countries to participate in global markets, foster trade and drive innovation. In a post, the MEA spokesperson Randhir Jaiswal posted: "Joining hands to promote cooperation in MSMEs."

"Today, India-US signed a landmark MoU that enables MSMEs of the two countries to participate in global markets, drive innovation, foster trade, and support women entrepreneurs."

The agreement was inked in New Delhi by S. C. L Das, Secretary, Ministry of Micro, Small and Medium Enterprises, Government of India, and Isabel Casillas Guzman, Administrator, Small Business Administration (SBA), Government of the United States of America, in keeping with the direction given by the Leaders of the two countries in the India-US Joint Statement of June 2023. The Memorandum of Understanding for promoting Cooperation on Small and Medium-size Enterprises provides a framework for both sides to discuss issues concerning micro, small and medium enterprises (MSMEs) and explore possibilities of cooperation.

It envisages the exchange of expertise between the two sides on issues related to improving MSME participation in the global marketplace through mutual visits as well as webinars and workshops on topics including access to trade and export finance; technology and digital trade; green economy; and trade facilitation. It also provides for the joint conduct of programmes for women entrepreneurs to empower them and facilitate trade partnership between women-owned small businesses of the two countries, according to information.

Boost to biz opportunities

Recognising the crucial role that MSMEs play in advancing inclusive growth, expanding exports and boosting employment, the two sides also agreed to explore the development of a "Business Matching Digital Platform" to boost business opportunities

Dhaka, Aug 14: Former Bangladesh Prime Minister Sheikh Hasina, who has been staying in India since she resigned and left the country on August 5 amid a student-led mass uprising, has started communicating with her Awami League party leaders over the phone and asked them to take the necessary initiatives to observe national mourning day on August 15.

The former Prime Minister made phone calls to her party leaders from India on Thursday, Friday, and Saturday, which several AL leaders confirmed to New Age daily. They said that Hasina asked them to pay tribute to her father and the country's founding President, Sheikh Mujibur Rahman, at Dhanmondi-32. They said that Hasina informed them that party leaders and activists in Gopalganj would observe the day in the district, paying rich tribute at the grave of Sheikh Mujib located in Tungipara of the district.

Bangladesh observes National Mourning Day on August 15 every year to mark the brutal assassination of its founding father, Sheikh Mujibur Rahman, also known as Bangabandhu, and most of his family members on August 15, 1975.

"My leader [Hasina] told me that she would come home soon. She asked us not to feel hapless," a mid-level leader of the AL's Dhaka north city unit told New Age, adding that Hasina asked them to file cases and general diaries with police about recent attacks once the police stations were reopened.

Several AL leaders said that they suspect that Saturday's attack on a patrol team of the army in Gopalganj was caused by some angry leaders and activists. They said that after the AL supporters of Gopalganj, the birthplace of Sheikh Hasina, got a message that she would come back home soon, they became emotional and attacked army personnel.

On Sunday night, at least 10 people, including five army personnel and journalists, were injured as AL leaders and activists attacked army personnel and other people from a demonstration they organised protesting at Sheikh Hasina's "forced resignation". A large group of AL leaders, including ministers and lawmakers, have either fled the country or kept their phones switched off since the resignation of Hasina.

The Hasina Government had had strained relations with the US for many years. Ahead of January's elections this year, she said "a white man" had offered

her smooth return to power in exchange for an airbase.

In her latest statement, Hasina, the longest-serving Prime Minister

in Bangladesh's history, warned the new interim government not be "used" by such foreign powers. Meanwhile, Bangladesh's

interim Government on Tuesday cancelled a national holiday on August 15. According to a press release issued by the

chief advisor's office, the cancellation of the August 15 holiday was approved in Tuesday's meeting of the advisory council.

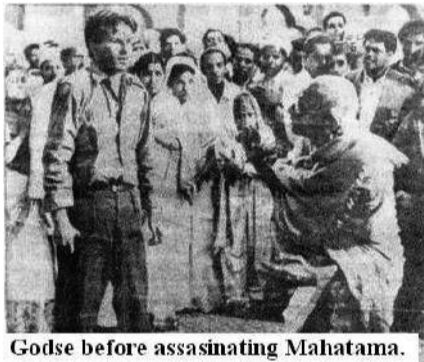

DRDO successfully flight tests LRGB

New Delhi, Aug 14: Defence Research and Development Organisation (DRDO) has carried out a successful maiden flight test of Long Range Glide Bomb (LRGB), GAURAV from Su-30 MK-I platform of the Indian Air Force (IAF).

The test was conducted off the coast of Odisha.

GAURAV is an air launched 1,000 kg class glide bomb capable of hitting targets at long distance, a Defence Ministry statement said. After being launched, the glide bomb steers towards the target using a highly accurate hybrid navigation scheme with a combination of INS and GPS data.

GAURAV has been designed and developed indigenously by the Research Centre Imarat (RCI), Hyderabad.

During the flight test, the glide bomb hit the target erected at Long Wheeler's island with

pinpoint accuracy. During the test launch, complete flight data was captured by telemetry and electro-optical tracking systems deployed by the Integrated Test Range along the coastline.

Senior DRDO scientists monitored the flight. Adani Defence and Bharat Forge, the development cum production partners also participated during the flight trial. Defence Minister Rajnath Singh complimented DRDO, IAF, and industry for the successful flight test. He termed it a major milestone in the country's effort to develop Indigenous defence technologies to further strengthen the Armed Forces' capability.

Secretary of Department of Defence R&D and Chairman DRDO Samir V. Kamat congratulated the entire DRDO team on conducting the successful flight test of LRGB.
