American Republican presidential candidate Donald Trump and Democratic opponent Kamala Harris will debate on September 10 on ABC, setting up the first face-to-face match-up between the rivals in what polls show is a close race.

Thursday's Palm Beach news conference was Trump's first public appearance since Harris selected Minnesota Governor Tim Walz as her running mate on Tuesday.

She told reporters after a Detroit-area campaign stop that she was open to discussing more debates, but a campaign official reiterated their position that a September 4 Fox debate is off the table.

Trump previously suggested he might back out of the ABC debate, scheduled before Harris, the US Vice-President, replaced President Joe Biden as the Democratic presidential candidate less than three weeks ago, upending the contest.
