Sub: Intimation to Stock exchange on imposition of fine by BSE Limited, as per Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that the BSE Limited vie. its' email dated June 28, 2024, imposed a penalty of Rs.1,23,900/- (Rupees One Lakh Twenty-Three Thousand Nine Hundred only) inclusive of GST for late submission of Statement on Impact of Audit Qualifications in PDF format which is a non-compliance of regulation 33 of the SEBI (LODR) Regulations 2015.

We would like to clarify that the company on May 24th 2024 sincerely submitted the Financial Results within the allotted period through the Listing Centre. Thereafter, we had received email from stock exchange about the discrepancies, and to rectify the discrepancies, the company had filed the results again along with the Statement on Impact of Audit Qualifications in PDF format through the listing centre on 20th June 2024. The Company hasn't done anything maliciously. It was simply an inadvertent technical error.

Therefore, the company is filing a request letter for a waiver of the fine imposed by BSE Limited. We are evaluating the circumstances surrounding the imposition of the fine and preparing a comprehensive letter requesting its waiver.
