The details of any change in the status and / or any development in relation to such proceedings;	Our company received a Show Cause Notice from Punjab GST Department on 27^{th} November 2024, for the period from April 2020 – March 2021. The notice was for disallowing the input tax credit under u/s 73 of CGST/SGST Act, 2017, and demanded INR 1,19,72,814/- (Tax – Rs.65,11,425/- Interest -Rs.48,10,248/- and Penalty Rs.6,51,141/-). However, we responded to the notice along with the supporting documents within the given time limit. The Asst. Commissioner, Mohali Ward, Ropar, Punjab GST Department reviewed our reply and issued an order dated 20 th February 2025 which was received by the company today, 21^{st} February 2025, at 2.30 pm. The demand amount as per the order is INR 66,00,529/- (Tax – 35,09,692/-, Interest – 27,39,868/- and Penalty – 3,50,969/-). This order is open for further submissions before the relevant authorities, and our company is in the process of responding within the stipulated time as mentioned in the order.
