Death threat to SRK: Accused lawyer remanded in police custody till Nov 18

MUMBAI, NOV 14 -- / A court here on Thursday remanded a lawyer from Chhattisgarh, arrested over allegations of threatening to kill Bollywood superstar Shah Rukh Khan, in police custody till November 18.

The Mumbai Police arrested the accused lawyer, Faizan Khan, from Chhattisgarh's capital Raipur on Tuesday. They brought him here after securing his transit remand from a Chhattisgarh court. On Thursday, the police produced the accused before a court in Bandra here and sought his remand for seven days for a probe into the matter. The accused's lawyers Amit Mishra and Sunil Mishra submitted that

Faizan Khan's phone was stolen before the alleged incident. They argued that the threat call made from his communication device was a conspiracy against him as he had earlier complained to the Mumbai police against Shah Rukh Khan over a dialogue in his movie 'Anjaam' (1994) referring to deer hunting.
