Pursuant to our disclosure dated July 17, 2024 on Voluntary Closure Directions of manufacturing activity of particular product at T-150 unit located at Tarapur, Maharashtra by Maharashtra Pollution Control Board (MPCB), we would like to inform that, Company has received conditional restart directions today i.e. August 7, 2024 from MPCB. Pursuant to aforesaid conditional directions Company shall carry out production activity after necessary permission from Directorate of Industrial Safety and Health (DISH)
