Subject: Consolidated Report of Scrutinizer on remote e-voting and voting by way of poll conducted at the 31st Annual General Meeting [Pursuant to Sections 108 of the Companies Act, 2013 and Rule 20 and 21 of the Company (Management and Administration) Rules, 2014.

I, Trusha D. Shah, of M/s Trusha D. Shah & Co., Practising Company Secretaries had been appointed as Scrutinizer by the Board of Laffans Petrochemicals Limited ("**the Company**") pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 and 21 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, to scrutinize the e-voting process (remote e-voting) and the physical ballot forms in respect of the resolutions contained in the Notice of the 31st Annual General Meeting (AGM) of Company that was held on Friday, 12th July, 2024 at 03:00 P.M. at Golden Industrial Estate, Plot No 28/B, Asian Paints Jitali Road, Village:- Jitali, Taluka Ankleshwar, Dist:- Bharuch, Gujarat.

The Company had availed the e-voting facility offered by Central Depository Services Limited ('CDSL') for conducting e-voting by the members of the Company.

The Company had also provided voting facility by way of poll to the members present at the AGM and had not cast their vote earlier through e-voting Facility. The members of the Company holding shares as on the "cut-off" date i.e. July 04, 2024, were entitled to vote on the Resolutions as contained in Notice of the AGM. The voting period for the e-voting commenced on Tuesday, 09 July, 2024 at 09:00 A.M. and ends on Thursday, 11 July, 2024 at 05:00 P.M. (IST) and my responsibility as a scrutinizer is restricted to making a Scrutinizer's report of the votes cast by the shareholders for the resolutions contained in the Notice of the AGM, based on the reports generated from the e-voting system provided by CDSL and scrutiny of the ballot papers received at the AGM.

After the time fixed for closing of the poll by the Chairperson, ballot boxes kept for polling were locked in my presence with due identification marks placed by me.

The locked ballot boxes were subsequently opened in my presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Share Transfer Agent of the Company and the authorizations / with the Company.

I did not find any poll papers invalid.

The votes cast under e-voting facility were thereafter unblocked in the presence of two witnesses who were not in the employment of the Company and after the conclusion of the voting at the Annual General Meeting the votes cast there under were counted.

There were no shares with differential voting rights in the Company hence there was no requirement of maintaining list of shares with differential voting rights.

I now enclose herewith my scrutinizer report on the result of the e-voting and poll in respect of the said resolutions.
