SUMMARY OF PROCEEDINGS OF THE 61ST ANNUAL GENERAL MEETING

The 61st Annual General Meeting (AGM) of the Members of Chowgule Steamships Limited ('the Company') was held on Monday, August 12, 2024, at 02:00 P.M. (IST) through Video Conferencing (VC)/ Other Audio Visual Means (OAVM). The Meeting was held in compliance with the Ministry of Corporate Affairs (MCA) circular dated April 8, 2020 read with circulars dated April 13, 2020, May 5, 2020, January 13, 2021, December 8, 2021, December 14, 2021 and May 5, 2022, December 28, 2022, and September 25, 2023 and other applicable provisions of SEBI (LODR) Regulations, 2015.

Mr. Vijay Chowgule, Chairman, chaired the meeting which was conducted through Video Conference. He welcomed the Members and informed that the quorum of Members under law was present (Total members present: 49 out of which 03 were Promoters).
