Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)

With reference to the above captioned subject, we hereby inform the Stock Exchange about the pending litigation of the Company pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023.

The pending litigation pertains to a tax dispute wherein the Company filed an appeal to the Customs, Excise and Service Tax Appellate Tribunal, Kolkata on 31.03.2010 against the Commissioner’s impugned order confirming the demand of Rs. 3,14,66,034/- towards Central Excise duty along with applicable interest.

The Company has received an Order from the Customs, Excise and Service Tax Appellate Tribunal, Regional Bench Kolkata – 1, dated December 10th, 2024. The Customs, Excise and Service Tax Appellate Tribunal has ruled in favor of the Company and has passed the following directions:

- i. The Demand of Rs. 89,855/- conceded by the appellant (the Company), out of Rs. 3,14,66,034/- has been confirmed and is payable along with interest.
- ii. The remainder of the demand confirmed by the impugned order has been set aside.
- iii. No penalties are imposable on the appellant.
