Tourism Ministry to launch Chalo India campaign

London, Nov 7: The Ministry of Tourism will launch its Chalo India campaign on the sidelines of the ongoing World Travel Mart in London.

Chalo India is a first-of-its-kind initiative to bring more foreign tourists to India, wherein the government will allow "friends" of diaspora members to get free visas. Five foreign nationals nominated by each Overseas Citizen of India (OCI) cardholder on a special portal will be eligible for a gratis e-visa (visa granted without fees).

There are about five million OCI card holders, as per government records. While each OCI holder can nominate up to five people, the total number of free e-visas



to be granted under the said initiative is one lakh, officials said.

As the special portal goes live, the OCI

cardholders will need to register on the same and key in the details of their nominated friends; they will be

assigned a unique code after due verification. The designated friends can then use the special code to avail of a free visa.

The UK is the third largest source market for inbound tourists to India. At almost 1.9 million, it also has one of the biggest Indian diaspora.

The Ministry of Tourism is participating at WTM London, being held from November 5 to 7, with a delegation of 50 stakeholders including state governments, inbound tour operators, airlines and hoteliers to showcase India's vibrant cultural diversity and the vast range of tourism products and immersive experiences, said a statement on Tuesday.

Goa's overpriced hotels blamed for declining tourism

Goa, Nov 7: Several Indians have come forward to share shocking stories of 'Goa taxi mafia' after a report suggesting that foreign tourism in the state has failed to reach pre-Covid levels went viral online. The CEIC Data report was shared by X user Ramanuj Mukherjee, who wrote: "Tourism in Goa is down in the dumps. Foreign tourists have abandoned the state already. Look at 2019 v 2023 numbers. Russians and Brits who used to visit annually have opted for Sri Lanka instead."

According to CEIC, only 1.5 million foreign tourists visited Goa in 2023, compared to 8.5 million in 2019. CEIC, which stands for China Economic Information Center, did say that domestic tourism in Goa had increased steadily



after the Covid dip, but Mukherjee predicted that this too would soon see a decline.

"Indian tourists still visiting, but soon likely to ditch it as word spreads about exploitation of tourists while there are so many cheaper comparable locations abroad," he wrote on X, where his post has gone viral with over 2 million views.

Since Mukherjee's post went viral with over 2 million views, many

social media users have come forward to share

stories of their own unpleasant experiences in the beach state, which is among India's top tourist destinations.

A number of Indians blamed the 'Goa taxi mafia' for the decline in tourism, revealing how they had been threatened and abused by cab drivers for offering rides to foreigners. Overpriced hotels emerged as another pain point.
