- 1) The Board of Directors of T T Limited (hereinafter referred as "the Company") at its meeting held on Thursday, October 24, 2024 has appointed us as scrutinizer pursuant to section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, and all other provision as applicable, to scrutinize the remote e-voting and e-voting conducted at its Extra-ordinary General Meeting ("EGM") in fair and transparent manner.
