MP Transco strengthens substation security

In a significant step to enhance the security of its extra-high voltage substations, Madhya Pradesh Power Transmission Company (MP Transco) has begun installing high-performance HD CCTV cameras across the state. This initiative, which is estimated to cost Rs 8.15 crore, is part of a broader effort to protect the power grid from theft and potential damage.

The first phase of the project includes installation of cameras at approximately 250 substations, with four of these located in Indore. The installation of these cameras is expected to save human labour in substation security and pa-



trols, while also creating a double layer of protection. This comes on the heels of MP Transco's use of drones for monitoring extra-high tension lines, marking the company's move towards tech-driven security solutions.

The decision to install cameras stems from a recent increase in theft of copper neutral strips from transformers—a critical component that, if removed, could lead to extensive damage and disruption of power supply. Thieves are targeting

these copper strips, which, while of little value to them, are essential for transformers,' explained MP Transco managing director Sunil Tiwari. The removal of these strips not only endangers the lives of the thieves but can also cause transformers to fail, potentially leaving electricity consumers without power for three to four months.

Tiwari highlighted that if such theft leads to a transformer being damaged, it could cost the company between Rs 5 to 6 crore in losses, as transformers are built to order and take months to replace. The newly-installed HD cameras will provide 360-degree coverage of substations,

with live feeds accessible to substation in-charges via their mobile devices. Furthermore, with the integration of an optical fibre network, MP Transco's central control centre at Shakti Bhawan Headquarters in Jabalpur will be able to monitor all 416 power substations across the state in real-time.

'With just one click, we can now monitor any substation from Jabalpur,' Tiwari said, emphasising the enhanced oversight that the new system will provide. MP Transco aims to protect its infrastructure and ensure uninterrupted power supply by preventing copper thefts that could otherwise result in significant financial and operational challenges.

Bank residents protest over poor basic amenities

Residents of Bank gram panchayat are facing a growing crisis due to neglected public services, with serious issues around cleanliness, water supply, and health concerns that have persisted for years. Despite repeated complaints to the local Sarpanch, the problems remain unresolved, causing frustration among the community.

The streets and neighbourhoods are reportedly filled with garbage, leading to an increase in diseases such as dengue and malaria. The condition of the roads has also deteriorated, with large potholes causing accidents. Adding to the woes, the drainage system is in disrepair, causing dirty water to overflow into homes and flood the roads. This has especially affected residents trying to reach the mosque for Namaaz, as stagnant water has made movement difficult and dangerous.

One of the most severe issues is the lack of clean drinking water. Taps installed under the government's Tap Water Scheme have not been operational, and roads dug up for the scheme's construction remain unpaved. Residents suspect widespread corruption in the execution of the scheme.

In response to the ongoing

neglect, the residents gathered at Noorani Nagar, where they submitted a memorandum outlining their grievances to local authorities. Residents likened the Sarpanch's inaction to that of the mythical Kumbhakaran, who slept through his responsibilities.

District officials, including CEO Priyanka Tagore, tehsildar Kamlesh Kushwaha, and panchayat secretary Jagdish Mehta, were quick to assure the protestors that a development committee would be formed to address their concerns.

The protest did not end there. The residents, joined by aware and socially active citizens, marched to the Raghuvir Grih Nirman Sanstha Green Park office, protesting against the Rs 400 monthly fee imposed for tap water and drainage services. They demanded that Raghuvir Nagar GrihNirman Sanstha be brought under the panchayat's control to resolve the issue.
