Dear Sir,

A. I, Mr. Hardik Darji, Proprietor of M/s IID and Associates, Practicing Company Secretaries, appointed as a scrutinizer vide Board Resolution dated 06^{th} August, 2024 to conduct the following: -

To Scrutinize Remote E-voting process and the E-Voting facility offered to the shareholders of the Company during the course of 30th Annual General Meeting [hereinafter referred as AGM) held on Tuesday, 24th September 2024, pursuant to the provisions of Section 108 of the Companies Act 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and pursuant to Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 in respect of the resolutions mentioned in the notice of 30th Annual General Meeting dated 24th September 2024.

dated January 13,2021 No. 21/2021 dated December 14,2021,No 02/2O22 dated May 05,2022,10/2022 dated December 28,2022 and 09/2023 dated September 25,2023 (Collectively referred to as MCA Circulars) and SEBI Circular dated May 12,2020 January 15,2021, May 13, 2022 and January 05,2023.

- C. I have also attended the AGM through Video Conferencing (VC)/ Other Audio-Visual Means (OAVM) as per the specific Login ID for Scrutinizer provided by Company.
- D. The Company had availed remote E-voting facility offered by Link Intime India Private Limited (LIIPL), for the purpose of E-voting by the members of the Company from Saturday, 21st September, 2024 (from 09:00 A.M. IST) and ended on Monday, 23rd September 2024 (till 05:00 P.M. IST). The E-voting facility was also offered during the course of AGM for the members who had not voted on the resolutions through remote E-voting facility, the CDSL E-voting platform was blocked thereafter.
- E. The votes cast under the remote E-voting facility and E-voting during AGM were thereafter unblocked and counted after the conclusion of the voting at the AGM in the presence of two witnesses (Names, Address and signature given below) who were not in employment of the Company.
- F. After the closure of the voting at the Annual General Meeting, the report on voting done for the meeting was generated in my presence and the voting was diligently scrutinized.
