1	The details of any change in the status and / or any development in relation to such proceedings;	In the matter of Petition filed by Tirupati Starch & Chemicals Limited (the 'Company') with Madhya Pradesh Electricity Regulatory Commission, Bhopal against the Madhya Pradesh Paschim Kshetra Vidyut Vitaram Co. Ltd against demand of Rs. 175.79 Lakhs as additional surcharge on captive power consumption, the Madhya Pradesh Electricity Regulatory Commission, Bhopal vide their order dtd. 11.09.2023 held that the additional surcharge under Section 42(4) of the Electricity Act 2003 is not leviable on the quantum of power consumed by Petitioner from its onsite 2 MW Steam Turbine Captive Power Plant. Respondent shall refund the amount deposited by Petitioner, if any, and withdraw the demand of balance amount along with consequential surcharge, if any, on account of additional surcharge on captive use of electricity within a period of one month from the date of this order. Further, Respondent shall not withhold prompt payment and online payment rebate on petitioner's HT connection on account of nonpayment of additional surcharge as the levy of additional surcharge has been disallowed on captive consumption. With the aforesaid observations and findings, the subject petition stands disposed of.
