brief details of dispute/litigation	HLV Limited (formerly known as ‘Hotel Leelaventure Limited’) has transferred the properties to Brook field by slumps sale. AAI has filed suit & Prayed for (i) a declaration that the act of the defendants in trying to dispose of/create third party rights in respect of any assets of the Seller, except the Mumbai property, in any manner whatsoever, is fraudulent and being done to defeat the right of AAI; (ii) an order of injunction restraining the defendants from creating any kind of third party rights in respect of any assets of the Seller, till such time the vacant possession of the Leased Property is handed over to AAI; and (iii) an order of injunction restraining the defendants from creating any kind of third party rights in respect of any assets of the Seller, till such time the dues of AAI are paid by the Seller. Written statement has been filed by the defendants in the matter.
