In continuation of our earlier letter dated 28.11.2024 on the captioned subject, we wish to inform you that, in respect of the Issue, the Fund Raising Committee at its meeting held today, i.e., 28.11.2024, approved the issue and allotment of 52,63,157 Equity Shares to 104 qualified institutional buyers at the issue price of ₹ 3,800 per Equity Share which is at a discount of ₹ 80.54 per Equity Share i.e. 2.0755% to the floor price of ₹ 3,880.54 per Equity Share, in accordance with the SEBI ICDR Regulations, i.e. at a premium of ₹ 3,798 per Equity Share, aggregating to ₹ 20,000 Million (Rupees Twenty Thousand Million), pursuant to the Issue.
