Teacher of pvt school booked for harassing student online

Gurgaon: A 24-year-old private school teacher was apprehended on Tuesday under the Pco Act for harassing a 12-year-old girl student on Instagram. The accused had allegedly forced the girl to follow him on Instagram and sent her objectionable messages. The girl's mother filed a complaint alleging that Sanju Verma, a teacher at a senior secondary school in the Madanpuri area, forced her daughter on her school premises to follow him on Instagram. "Due to his pressure, my daughter logged into an Instagram account from my phone and followed Sanju Verma's account, after which he sent her objectionable messages on Instagram on May 24," she alleged. Scared by the teacher's harassment, the girl told everything to her mother. In her police complaint, the girl's mother requested the police to initiate stringent action against the accused. The case has been registered at women's police station (West) under Section 12 (punishment for sexual harassment) of the Protection of Children from Sexual Offences (Pco) Act on Monday. On Tuesday, a police team apprehended Sanju. Sub Inspector Neha Rathni said, "We have started collecting evidence and the accused has been joined in the probe. We will record his statement. He will appear for questioning soon."

Chinese nat'l among five arrested for cyber fraud

Noida: Five persons, including a Chinese national, part of a larger cyber fraud network, were arrested from Noida on Wednesday. Police said they got a whiff of the racket with a tip-off about a bulk purchase of SIM cards, some of which are active in foreign countries and being used to run social media accounts to cheat people on the pretext of investments through platforms like Telegram, WhatsApp. The money was then transferred into mule accounts, a senior official said. Two laptops, 21 mobile phones, 223 SIM cards, seven Aadhaar cards, etc, have been seized from the men. "The group duped people by adding them to chat groups and luring them with promising returns upon hefty investments," said DCP Vidya Sagar Mishra, adding that an alert about a bulk purchase of Rs 51 lakh from a mule account led to the arrests.

ACP (Noida 3) Shavya Goyal said, "The gang used mule bank accounts to handle the money. They approached people (mule account holders) and obtained their bank accounts in exchange for money for each transaction."

"For each transaction through mule accounts, the accused account holders were paid Rs 3,000 for savings accounts and Rs 20,000 for corporate accounts," stated the DCP.

An FIR has been lodged at the Expressway Police Station under IPC sections 420 (cheating), 120B (criminal conspiracy), 467, and 468 (related to forgery).

Memorandum by Bam Bam Maharaj Nauhattia to force Kejriwal to resign from the post of Chief Minister on 1st June

New Delhi. Bam-Bam Maharaj Nauhattia will give a memorandum on behalf of the people of Delhi to demand and force Kejriwal to resign from the post of Chief Minister on 1st June at 5.00 pm at Sheeshmahal, 6 Flag Road. Bam Bam Maharaj Nauhattia told reporters that we have demanded in the letter that Kejriwal, unfortunately for the people of Delhi, you are sitting on the post of Chief Minister of Delhi, the people of Delhi recommend dissolving or suspending the Delhi Assembly without demanding your resignation from the post of Chief Minister. He said that the people of Delhi, whatever your false promises may be, have given you the governance of Delhi with complete majority and the people of Delhi have given you the majority for the governance of Delhi, not to any other MLA or your wife Sunita Agarwal or anyone else to hand over the post of Chief Minister in case you go to jail. If you do or will do this then it will be considered rejected by the democracy of Delhi because after you went to jail, no one has been given the responsibility of Chief Minister of Delhi till now whereas a claim has been made in the Delhi Assembly regarding the establishment of the government of the citizens of Delhi state, so when a claim is pending before the Lieutenant Governor in a legal manner, then due to your mistake and negligence, no one nominated by you can become the Chief Minister of Delhi because the people of Delhi have not given him their majority. Therefore, it will be better if you do not do any kind of trickery after

receiving this letter. He also said that Kejriwal, you are currently a judicial prisoner and not one but many serious allegations are leveled against you, so the democracy of Delhi demands Kejriwal to resign from the post of Chief Minister without dissolving the Assembly and without recommending the suspension of the Assembly.

Woman accuses doctor of trying to convert her son, goes to police

Gurgaon. Police were called in to a society in Greater Faridabad on Sunday after a woman, a former resident of the apartment complex, came there and created a ruckus alleging that a doctor was forcibly trying to get her son to convert his religion. The woman alleged that her 16-year-old son, who is pursuing BBA from a college in Delhi's Dwarka, was in regular touch with the doctor although her family had moved out of the Faridabad society last year. She alleged that her son was influenced to join WhatsApp groups of "dangerous outfits". "The doctor and his family have been influencing my 16-year-old son. They had become quite friendly when we used to live here till we moved to Gurgaon in 2023. We discovered that they are still connected virtually, hence we decided to come see the doctor in person," the woman claimed. She said the doctor's family told her he wasn't in the country right now. "His family claims that he is somewhere abroad. We want an explanation and action against him and his family for brainwashing our child and getting him involved in dangerous activities," she said. After the woman came to the society, other residents called police who took them to a police station where some members of Hindu outfits also arrived. She then filed a complaint there. "The investigation is ongoing, and senior officials have been informed about the matter. Further action will be taken after the investigation is complete," said Bhagwan, SHO of BPTP police station. An FIR was yet to be registered till Monday evening. We also published the following
