Sub: Disclosure of the details of allotment in the Issue (as defined hereinafter) by Sansera Engineering Limited (the "Company") in accordance with the Securities and Exchange Board of India (Listing Obligations and Disclosures Requirements), 2015, as amended (the "SEBI Listing Regulations").

Re: Qualified institutions placement of equity shares of face value of ₹ 2 each (the "Equity Shares") by the Company under the provisions of Chapter VI of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations"), and Sections 42 and 62 of the Companies Act, 2013 (including the rules made thereunder), as amended (the "Issue").

In continuation of our letter dated October 15, 2024 on the captioned subject, we wish to inform you that, in respect of the Issue, the board of directors at its meeting held today, i.e., October 15, 2024, approved the allotment of 77,22,007 Equity Shares to eligible qualified institutional buyers at the issue price of ₹ 1,554/- per Equity Share, i.e. at a premium of ₹ 1,552/- per Equity Share, which takes into account a discount of 4.98% (i.e. ₹ 81.48 per Equity Share) to the floor price of ₹ 1635.48 per Equity Share, as determined in terms of the SEBI ICDR Regulations), aggregating to approximately ₹ 1,200 crores (Rupees One Thousand Two Hundred Crores), pursuant to the Issue.

The Issue opened on October 10, 2024 and closed on October 15, 2024 and the same was intimated to you through our letters dated October 10, 2024 and October 15, 2024, respectively.
