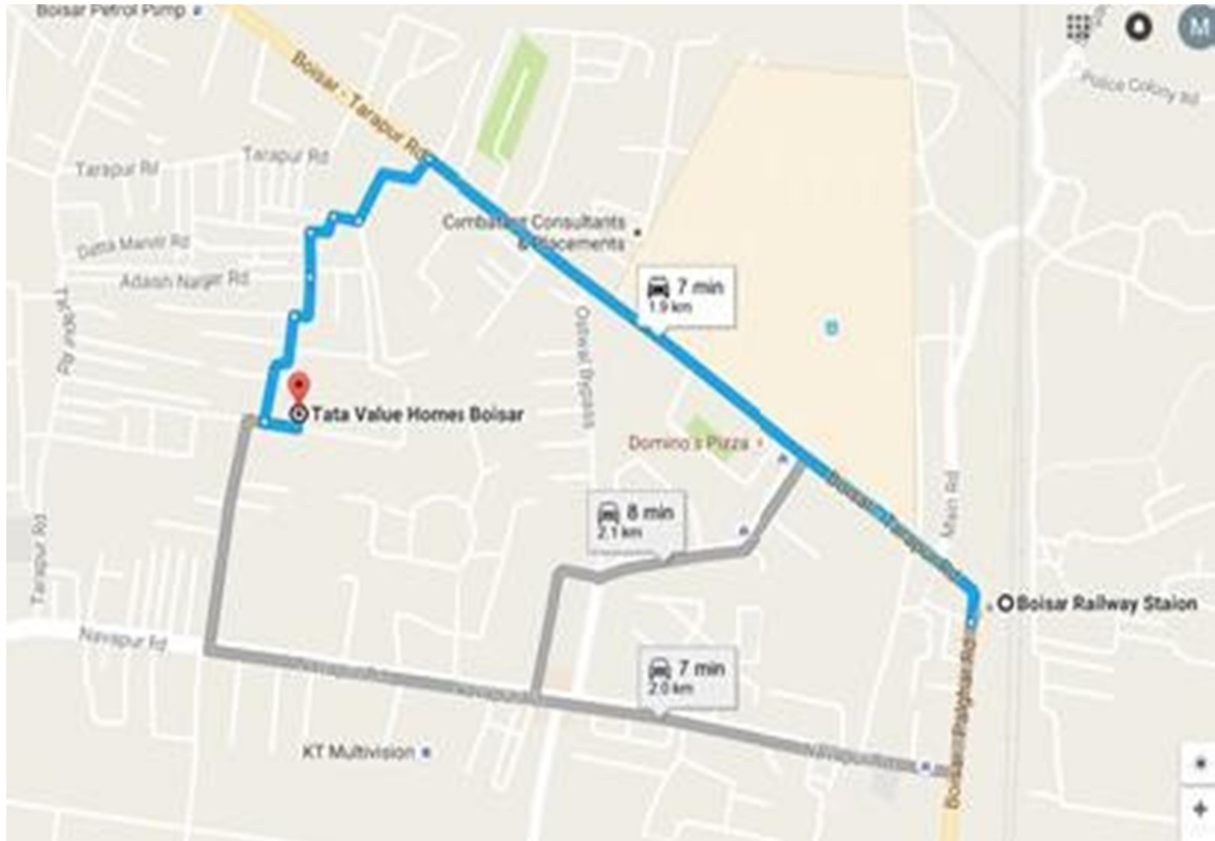

During the year under review, Mr. Vikas Poddar, Executive Director & CEO, Lunkaran Kyal, Executive Director & CFO and Mr. Tejas Trivedi, Company Secretary & Compliance Officer had resigned effective from 11.10.2023 and 31.05.2024.






