Sub: Disclosures under Regulation 29(2) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011

Axis Asset Management Company Limited ("Axis AMC") is the Investment Manager of Axis Mutual Fund. Axis AMC is a company incorporated in India under the Companies Act, 1956 and is having its Registered Office at One Lodha Place, 22nd & 23rd Floor, Senapati Bapat Marg, Lower Parel, Mumbai - 400013. Axis Mutual Fund ("Axis MF") is a mutual fund constituted in India and registered with the Securities and Exchange Board of India ("SEBI") under SEBI (Mutual Funds) Regulations, 1996 vide registration no. MF/061/09/02.

Sansera Engineering Limited has further issued 77,22,007 shares under QIP on October 15, 2024. Consequently, the issued capital of the target company has increased resulting in a decrease in percentage of holding by the schemes of Axis AMC.

Further, Axis Mutual Fund disposed of equity shares of Sansera Engineering Limited (Target Company) on October 15, 2024 thereby reducing the holding of equity share capital. The said further issuance of equity shares by target company and disposal by the schemes of Axis AMC has resulted in equal to or more than 2% change in equity share capital holding by schemes of Axis Mutual Fund since last reporting under regulation 29(1) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011.

In terms of Regulation 29(2) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, any acquirer, who together with persons acting in concert with him, holds shares or voting rights entitling them to five per cent or more of the shares or voting rights in a target company, shall disclose every change in holding representing two per cent or more of the shares or voting rights in such target company and every stock exchange where the shares of the target company are listed within 2 working days.


Please note that the sale of shares of Sansera Engineering Limited have been carried out in the ordinary course of investment (portfolio investments) by the schemes of Axis Mutual Fund.
