Dear Sir.

With reference to the captioned subject and in continuation of the letter dt. 11.03.2024 (copy enclosed) submitted by Power Grid Corporation of India Limited ("POWERGRID"), we wish to inform that POWERGRID has executed a Shareholders' Agreement ("SHA") with Rajasthan Rajya Vidyut Prasaran Nigam Limited ("RVPN") on 30.09.2024.

2.	Purpose of entering into the agreement;	POWERGRID and RVPN have entered into a SHA to form a Joint Venture Company ("JVC") for development of Intra-State Transmission System in the State of Rajasthan with an equity participation of 74% by POWERGRID and 26% by RVPN.

Significant terms of the agreement (in brief) special rights like right to appoint directors, first right to share subscription in case of issuance of shares, right to restrict any change in capital structure etc.;	As per SHA, the proposed JVC shall have 10 (Ten) Directors of which 7 (Seven) shall be nominated by POWERGRID and 3 (Three) shall be nominated by RVPN.  POWERGRID and RVPN will hold 74% and 26% Equity Share Capital, respectively, in the proposed JVC. POWERGRID and RVPN will have right to subscribe to the shares in proportion to their respective shareholding in the proposed JVC.



		Any change in capital structure of the proposed JVC will require consent of both POWERGRID and RVPN.

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that Power Grid Corporation of India Limited (POWERGRID) has executed Memorandum of Understanding (MoU) with Rajasthan Rajya Vidyut Prasaran Nigam Limited (RRVPNL) on 10<sup>th</sup> March, 2024 to incorporate a Joint Venture (JV) Company for development of Intra State Transmission System in the state of Rajasthan with an equity Participation of 74% by POWERGRID and 26% by RRVPNL. The proposed JV company shall undertake projects worth upto Rs. 10,000 crore in a phased manner.
