LIMITED REVIEW REPORT

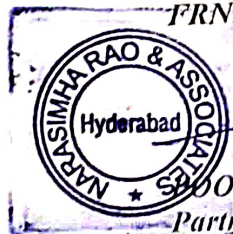
Review report to HEALTHY INVESTMENTS LIMITED
