Sr. No.	Particulars	Details
1.	Insurance amount claimed and realized by the listed entity for the loss/damage	The Company has filed an insurance claim of approximately ₹221 crore for the damages incurred, which is currently under assessment by the insurer. An ad hoc advance of ₹50 crore has been released, with the final settlement to be determined following the completion of the assessment.
2.	The actual amount of damage caused due to the natural calamity or other force majeure events.	The preliminary assessment indicates damage amounting to approximately ₹221 crore, excluding business interruption costs, which will depend on the duration of non-operational status.
3.	Details of steps taken to restore normalcy and the impact of the natural calamity/other force majeure events on production or service, financials of the entity.	The Company has already commenced restoration efforts. The financial impact will be limited to the portion of the damage not covered by the insurance policy (deductibles). The fire incident does not have a material effect on production, services, or the Company's financials, as the damages are covered under the insurance claim.
