## INDEPENDENT AUDITOR'S REVIEW REPORT ON REVIEW OF INTERIM CONSOLIDATED FINANCIAL RESULTS

Our responsibility is to express a conclusion on the Statement based on our review.

We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India (ICAI). ## NOTES TO CONSOLIDATED FINANCIAL RESULTS :

1. The Board of Directors has declared a third interim dividend of Rs. 8.10 per share of Rs. 10/- each.

The Company had declared and paid first interim dividend of Rs. 9.00 per equity share and second interim dividend of Rs. 7.20 per equity share of Rs. 10/- each during the year.

The total interim dividends for the year declared aggregates to Rs. 24.30 per equity share.

  - delivered its 2011 built Supramax Dry Bulk Carrier named Jag Rani which was contracted for sale in earlier quarter.

The Company had declared and paid first interim dividend of Rs. 9.00 per equity share and second interim dividend of Rs. 7.20 per equity share of Rs. 10/- each during the year.

The total interim dividends for the year declared aggregates to Rs. 24.30 per equity share.

- 3. Following were the changes to the fleet during and subsequent to the quarter:
  - delivered its 2011 built Supramax Dry Bulk Carrier named Jag Rani which was contracted for sale in earlier quarter.
  - delivered its 2005 built Suezmax Crude Tanker named Jag Lalit which was contracted for sale in earlier quarter.

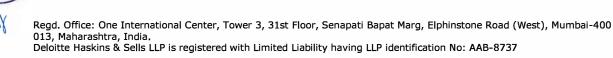
